All that certain lot, tract or parcel of land within the J. CAMBURN Survey, Abstract No. 244, Smith County, Texas, being part of a called 39.77 acre tract conveyed to William Ellis Wade and Regina Wade as described and recorded in Volume 1339, Page 58 of Deed Records of Smith County, Texas, and this 10.092 acre tract being more fully described as follows:

Bearings are based on the Texas State Plane Coordinate System, Texas North Central Zone 4202, N.A.D. 1983

BEGINNING at a 1/2" Iron Rod set for the Northwest corner of herein described tract, being in the East boundary line of a called 37.3 acre tract conveyed to James Sherman Henry Estate;

THENCE North 88 deg. 59 min. 10 sec. East across said 39.77 acre tract a distance of 749.13 feet, to a Cotton Spindle set for the Northeast corner of herein described tract, being near the centerline of County Road No. 245;

THENCE With the Centerline of County Road No. 245 as follows:

- 1)South 01 deg. 32 min. 31 sec. East across said 39.77 acre tract a distance of 91.07 feet to a Cotton Spindle Set;
- 2)South 03 deg. 43 min. 11 sec. West across said 39.77 acre tract a distance of 92.89 feet to a Cotton Spindle Set;
- 3)South 04 deg. 31 min. 26 sec. West across said 39.77 acre tract a distance of 87.24 feet to a Cotton Spindle Set;
- 4)South 02 deg. 48 min. 40 sec. West across said 39.77 acre tract a distance of 96.23 feet to a Cotton Spindle Set;
- 5)South 04 deg. 17 min. 55 sec. West across said 39.77 acre tract a distance of 110.32 feet to a Cotton Spindle Set;
- 6)South 02 deg. 04 min. 44 sec. East across said 39.77 acre tract a distance of 98.36 feet to a Cotton Spindle Set
- 7)South 06 deg. 57 min. 38 sec. East across said 39.77 acre tract a distance of 30.14 feet to a Cotton Spindle Set for the Southeast corner of herein described tract, being in the North boundary line of a called 30 acre tract conveyed to Sarah L Dansby as described and recorded in Volume 1564, Page 182;

THENCE South 88 deg. 20 min. 13 sec. West with the North boundary line of said 30 acre tract a distance of 715.32 feet to a 1/2" Iron Rod set for the Southwest corner of herein described tract, same being an ell corner of a called 37.3 acre tract conveyed to James Sherman Henry Estate;

THENCE North 01 deg. 39 min. 44 sec. West with the East boundary line of said Henry Estate a distance of 612.79 feet to the **POINT OF BEGINNING** AND CONTAINING **10.192 ACRES** OF LAND.
