

This survey has been prepared to delineate the twelve (12.00) acre parcel shown heron. The parcel and New 20' wide ingress/egress and utility easement are the subject of this survey. This survey was prepared without benefit of a title report. The client for this survey is Lawrence Wilson.

An existing Survey of Record prepared for a 68.30 acre parcel (B-410, Filed 6-23-04, Catron County Clerk) served as a reference of record for the preparation of this survey. The Record of Survey was performed by Larry Kay Whitmer R.P.L.S. 8498, New Mexico.

Information from The Catron County Assessor/ Recorder was used to delineate adjacent ownership. The Dependent Resurvey accepted/approved by The Department of The Interior, General Land Office, February 1, 1938, was also used as a reference.

The Deed of Record for this survey (Vol.26 of Deed 1 Page 132-133, Catron County Clerk) was used


The section corner (Sec. 14/13; 23/24) and the 1/16<sup>th</sup> (N 1/16<sup>th</sup> S23/S24) corner shown by the existing survey were field verified. They were used as the best reference tie points for the replacement of a missing corner and establishment of the new (12 acre) parcel corners. The NE. corner of the Record Parcel was also recovered.


The North& South line (calculated) between Section 23 and 24 is the basis of bearing for the Legal Description prepared for and shown by this survey.

All distances for this survey are published as ground distances and were obtained by GPS survey method.
