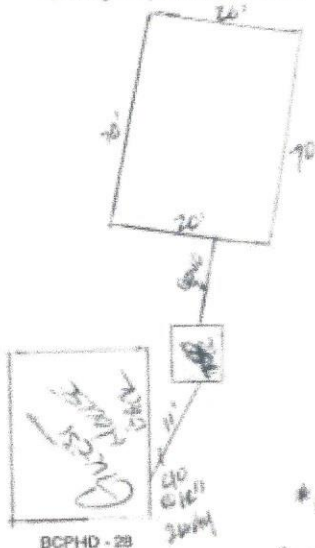

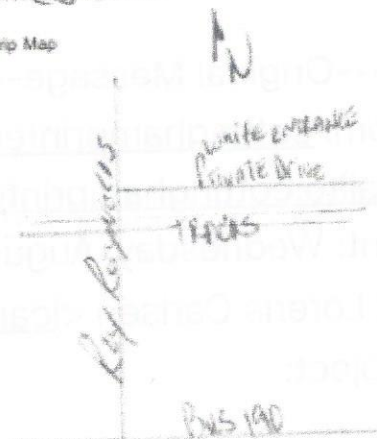
Drawing of System: (Not to scale)
