




METES AND BOUNDS DESCRIPTION 18.123 ACRES

All that certain tract or parcel containing 18.123 acres of land in the Robertson Asher Survey, A-10, Upshur County, Texas, being all of a tract which was called 17.8 acres conveyed from Rogie Melton to Dorothy Parker, by an instrument of record in Volume 389, Page 393, Upshur County Deed Record (UCDR), said 18.123 acres being more particularly described by metes and bounds as follows, basing bearings on the Texas Coordinate System of 1983, North Central Zone, to wit:

BEGINNING at a 3/8" iron rod found for southeast corner, being the southeast corner of said 17.8 acre tract and northeast corner of a tract which was called 17.57 acres conveyed from Billy Don Mattox to Thomas R. Barrett, et ux, by an instrument of record in Clerks File #201807071, Upshur County Official Public Record (UCOPR), Iving in the west right of way (R-O-W) line of US Highway 259 (US 259), from which a TXDOT Type I concrete monument found for angle point of said 17.57 acre tract bears: S10°36'21"E, 438.05 feet;

THENCE departing US 259, S67°27'46"W, 1,274.73 feet along the common line of said 17.8 acre tract and said 17.57 acre tract to a 3/8" iron rod found for southwest corner, being the southwest corner of said 17.8 acre tract and northwest corner of said 17.57 acre tract, lying in the east line of a tract which was called 62.9 acres conveyed from W.W. Summerlin, et ux to W.J. McIntyre, et ux, by an instrument of record in Volume 219, Page 94, UCDR, from which a 3/8" iron rod found for southwest corner of said 17.57 acre tract bears: S34°06'20"E, 870.93 feet;

THENCE N34°06'20"W, 433.00 feet along the common line of said 17.8 acre tract and said 62.9 acre tract to a 5/8" iron rod set for northwest corner, being the southwest corner of said 17.8 acre tract and a northeast corner of said 62.9 acre tract, lying in the south line of a tract which was called 58.109 acre, Tract No. 1, conveyed from Karen Lee Wright Macon, et al to Audrey Pauline Wright, by an instrument of record in Volume 222, Page 423, Upshur County Official Record (UCOR);

THENCE N56°28'47"E, 1,473.97 feet along the common line of said 17.8 acre tract and said 58.109 acre tract to a 5/8" iron rod found for northeast corner, being the northeast corner of said 17.8 acre tract and southeast corner of said 58.109 acre tract, lying in the west line of a tract which was called 19.2 acres conveyed from Louise Dodson to Victor M. Perez, by an instrument of record in Clerks File #201106354, UCOPR;

THENCE S33°00'25"E, 215.00 feet along the common line of said 17.8 acre tract and said 19.2 acre tract to a 5/8" iron rod set for angle point, being an angle point of said 17.8 acre tract and south corner of said 19.2 acre tract, lying in the west R-O-W line of US 259;

THENCE S10°37'20"E, 63.30 feet along the common line of said 17.8 acre tract and USS 259 to a TXDOT Type I concrete monument found for angle point, being an angle point of said 17.8 and US 259;

THENCE S04°55'44"E, 201.23 feet continuing along said common line to a TXDOT Type I concrete monument found for angle point, being an angle point of said 17.8 and US 259;

THENCE S10°38'19"E, 245.13 feet continuing along said common line to the PLACE OF BEGINNING, containing 18.123 acres of land, more or less. A certified plat has been prepared under the same job number as a part of this professional service.
