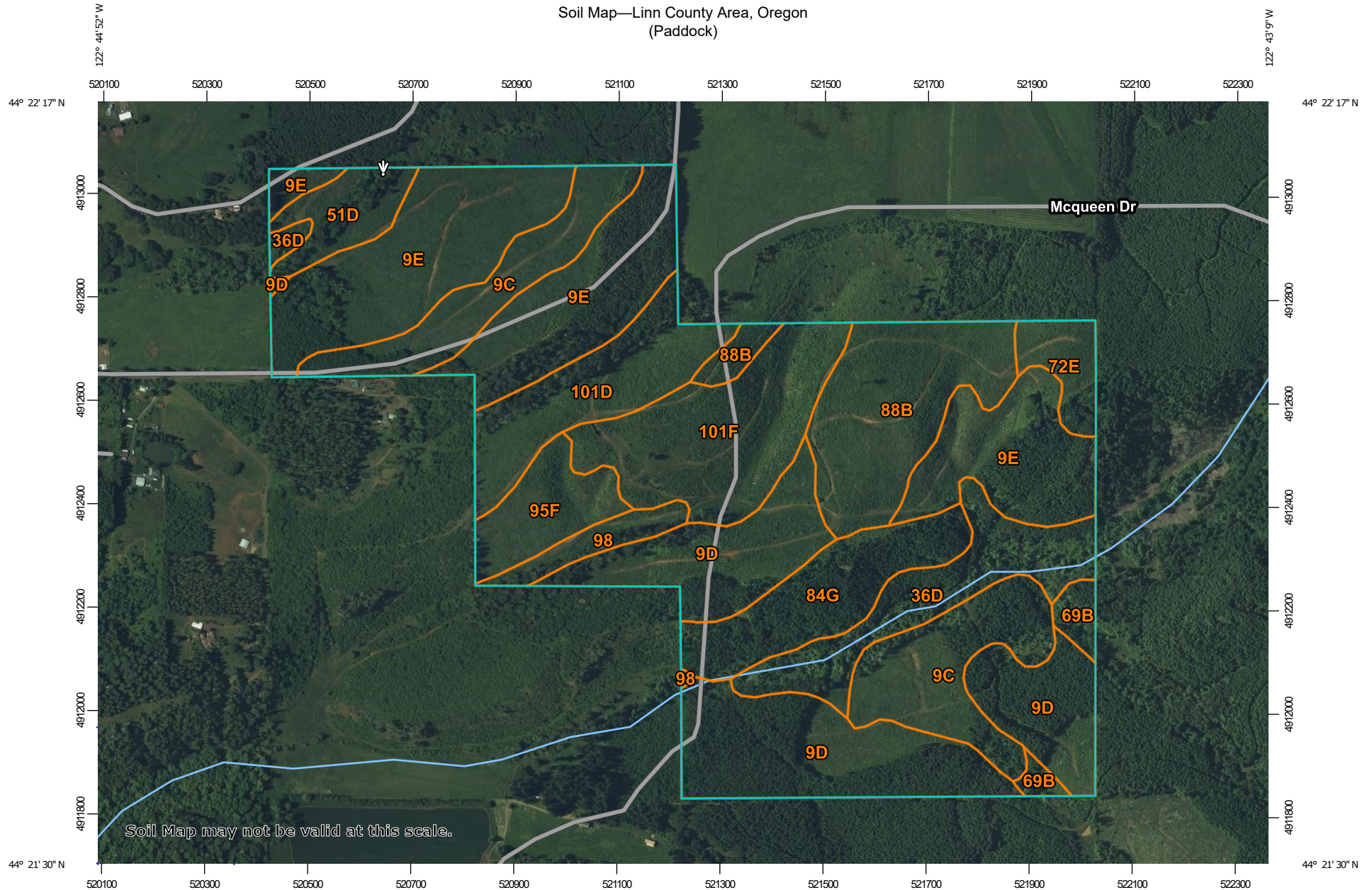
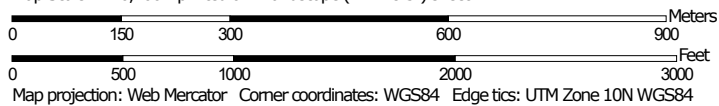


Soil Map—Linn County Area, Oregon (Paddock)
