

- The timber consist of 28 acres of mature pine and hardwood mostly around the house, lake and creek.
 About 107 acres of mature pine plantation were clear-cut in 2020 and could easily be replanted in longleaf or loblolly pine or let regrow naturally into a mixed pine & hardwood forest


