Field Notes Description

A 72.40 Acre Tract, more or less, being a portion of a 483.47 acre tract, same being all of Fifth Tract and Sixth Tract recorded in Volume 181, Pages 620-622 of the Deed Records of Lavaca County, Texas and Jackson County, Texas, being a portion of the John H. Scott Survey, Abstract 576 and the John H. Scott Survey, Abstract 219;

Being more fully described by metes and bounds as follows:

- BEGINNING: at a point in the centerline of County Road 18, in the north line of said 483.47 nore tract, at the southeast corner of a 61.16 acre tract recorded in Volume 408, Page 862 of the Deed Records of Lavaca County. Texas, the southwest corner of a 126.01 acre tract recorded in Volume 459, Pages 94-100 of the Official Records of Lavaca County, Texas and at the northeast corner of said 108,88 acre tract (Tract 1) dually surveyed, for the northwest corner of this herein described tract;
- THENCE: N 33°24'10" E along the south line of said 126.01 acre tract, the north line of said 483.47 acre tract and the north live of this herein described tract at 38.19 feet pass a 5/8" from rad with cap stamped "RPLS 6368" set for a line marker, in all a distance of 3212.99 feet to a 1/2" iron pipe found at the northeast corner of said 483.47 acre tract, for the northeast corner of this herein described tract;
