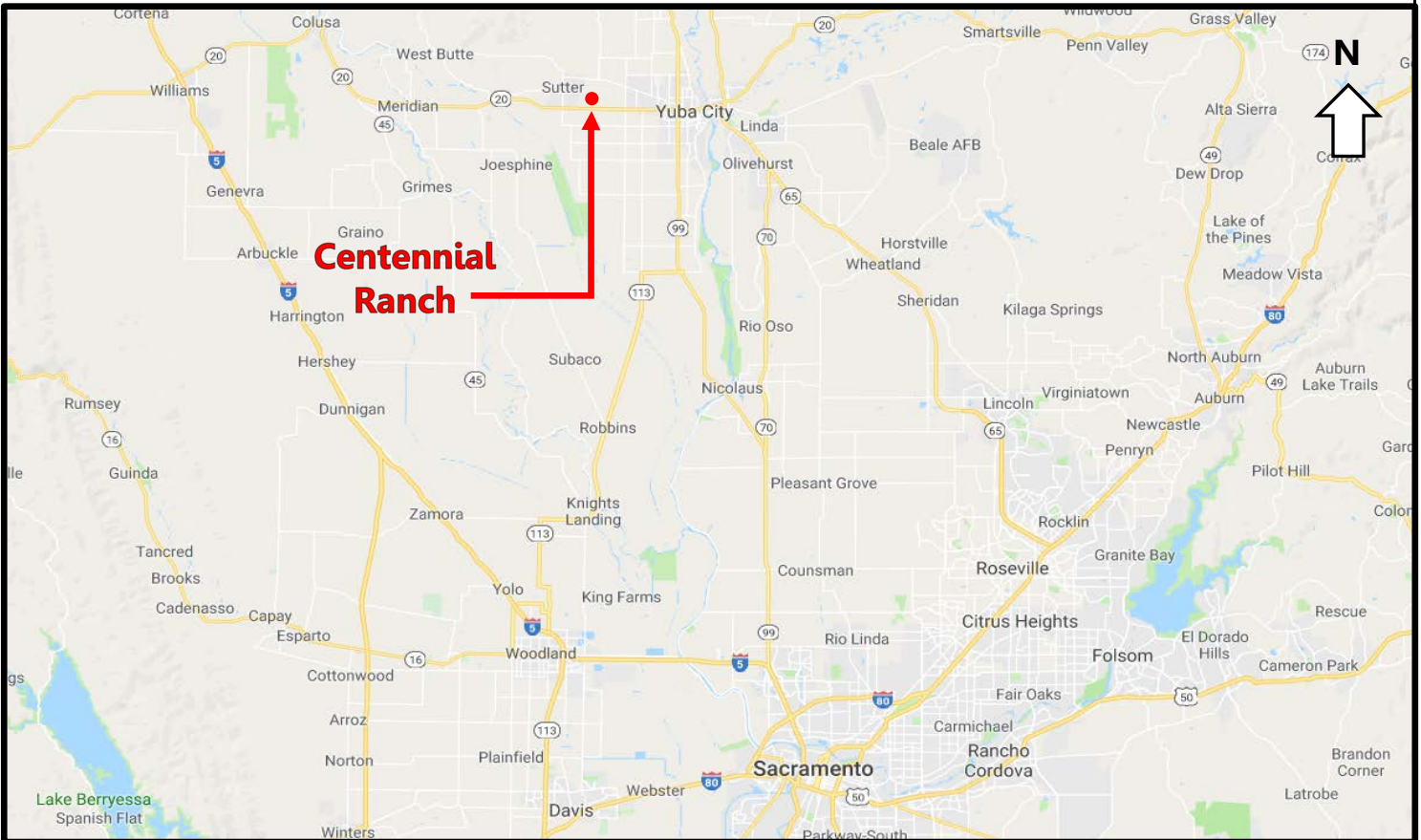

LOCATION

The property is located along the east side of Acacia and the south side of S. Butte Road, adjacent to the community of Sutter, in Sutter County.

DESCRIPTION

The property contains a total of 59+/- acres, of which 58 acres are improved with Almonds planted in 2006. Varieties include Non Pareil, Carmel and Butte. Irrigation is provided by one agricultural well.

General Commercial Zoning

According to the Sutter County Planning department, approximately 38+/- acres are zoned General Commercial (GC) while the balance is zoned Agriculture (AG). The General Commercial zoning allows for a full range of neighborhood, community, highway, and regional retail, as well as office, service, and related uses to serve residents, employees, and visitors. The GC District implements the General Plan Commercial (COM) land use designation.

Utilities in the area are provided by the Sutter Community Service District and Pacific Gas and Electric Co. Sewage in the town of Sutter is accommodated by the development of on-site septic systems.

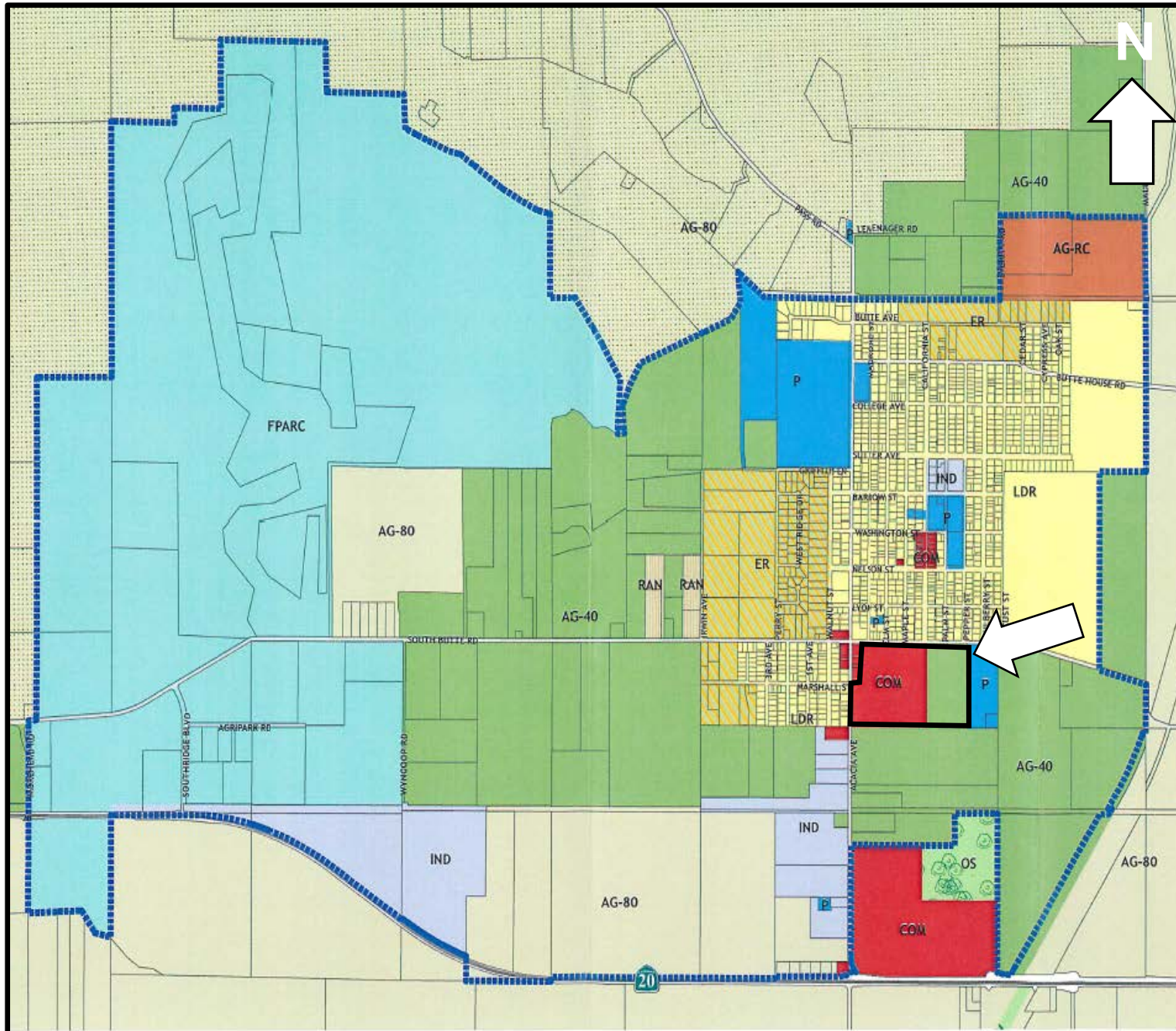

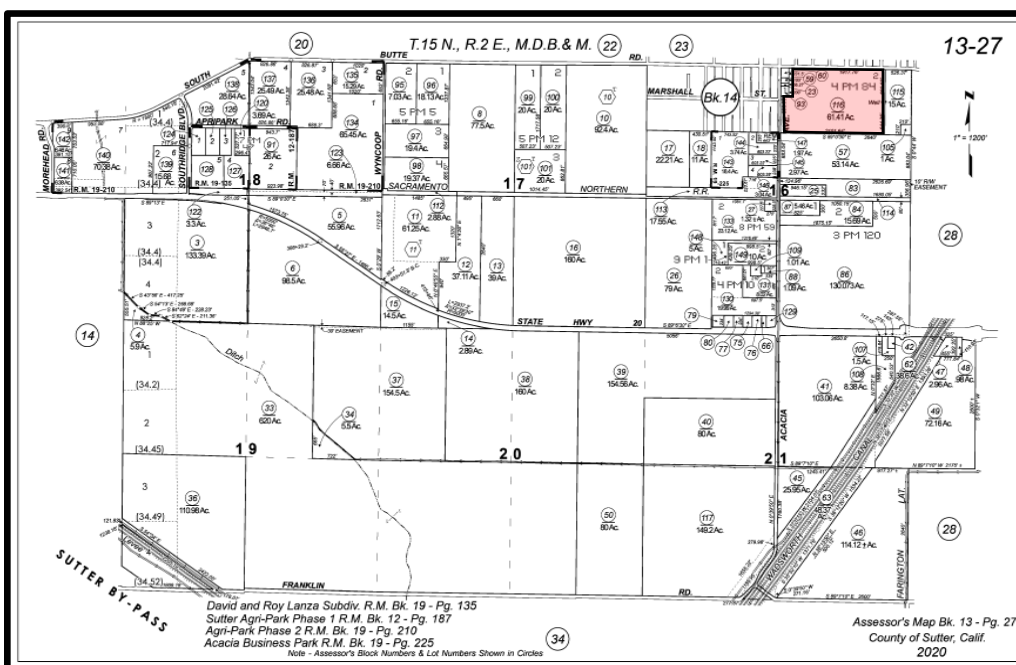
