

# PROPERTY OVERVIEW

This elite South Georgia farm exhibits all of the essentials for a quality, recreational investment. The farm boasts income producing irrigated crop fields, balanced habitat, and a robust whitetail deer density. The upland pine plantations feature approximately 100 acres of merchantable timber with gentle, rolling topography. The wetlands feature cypress and hardwood for excellent transitional habitat and eco diversity. There is a significant amount of upland hardwood that has been thinned for enhanced mast production and understory forage availability. Simply put, this property has been designed to function as a trophy grade whitetail hunting property.

A conservation easement protects the acreage from commercial development, but allows for habitat management, farming and recreational uses. Peanuts and corn serve as the prevailing crop in the area and as a result, the deer herd is healthy and thriving. Baseline herd genetics in the area are outstanding, which makes it easy for ownership to enjoy trophy whitetail deer with minimal input. There are existing roads and previously cleared food plots that make this property turn-key for the hunting enthusiast. Irrigated farm leases and hunting leases are both in high demand so there is significant income potential for the investor.






