FIELD NOTE DESCRIPTION TRACT 3 13.552 ACRES IN THE WILLIAM MCDONALD SURVEY, ABSTRACT NUMBER 30, WALKER COUNTY, TEXAS

BEING a 13.552 acre tract of land, situated in the William McDonald Survey, Abstract Number 30, Walker County, Texas, and being a portion of that certain called 599.83 acre tract described as "Tract 1" in instrument to Maurice Estlinbaum, recorded in Volume 1353, Page 692 of the Official Records of Walker County, Texas (O.R.W.C.T.), said 13.552 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for the southwesterly corner of the herein described 13.552 acre tract, from which a 1/2 inch iron rod with cap found for the common southerly corner of said 599.83 acre tract and that certain called 33.42 acre tract described in instrument to Lex Forgason and Stacey Forgason, recorded under Instrument Number 63823 O.R.W.C.T., bears. South 87°21'11" West, 975.63 feet, said **POINT OF BEGINNING** having a Texas State Plane Coordinate value of **N**: 10,234,643.11, **E**: 3,787,468.07, Texas Central Zone (4203), grid measurements:

THENCE North 02°38'49" West, severing, over and across said 599.83 acre tract, at a distance of 885.48 feet pass a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for reference in the southerly margin of Robinson Creek Road, in all, a total distance of 915.48 feet, to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set in the southerly edge of said Robinson Creek Road for the northwesterly corner of the herein described 13.552 acre tract;

THENCE North 87°21'11" East, 644,82 feet, within the margins of said Robinson Creek Road, the northerly line of said 599.83 acre tract, to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for the northeasterly corner of the herein described 13.552 acre tract, from which a 4 inch by 4 inch concrete monument found for reference bears, North 87°21'11" East, 2072.41 feet:

THENCE South 02°38'49" East, continuing over and across said 599.83 acre tract, at a distance of 30.00 feet pass a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for reference in the southerly margin of said Robinson Creek Road, in all, a total distance of 915.48 feet, to a 1/2 inch iron rod with cap stamped "TPS 100834-00" set for the southeasterly corner of the herein described 13.552 acre tract:

THENCE South 87°21'11" West, 644.82 feet, continuing over and across said 599.83 acre tract, to the **POINT OF BEGINNING** and containing a computed area of 13.552 acres of land within this Field Note Description.
