FIELDNOTE DESCRIPTION

11.12 ACRE TRACT

BEGINNING at a found 1/2" iron rod with yellow cap stamped "RPLS 4748" at a corner post at the northwest corner of above mentioned 22 acre tract, same being the northeast corner of a 78.03 acre tract of land to Leroy James Klement (TRACT TWO - 1106/864 ORMCT), located in the south right-of-way line of County Road No. 114;

THENCE along the south right-of-way line of County Road No. 114 and generally along a fence, South 71 degrees 07 minutes 34 seconds East, a distance of 226.24 feet to a found 1/2" iron rod with yellow cap stamped "RPLS 4748" at the northwest corner of a 100 acre tract of land to Jehova Bazaldua, et ux, (825/642 ORMCT);

THENCE along the east line of said 22 acre tract, same being the west line of said 100 acre tract and generally along a fence, the following courses and distances:

South 18 degrees 09 minutes 33 seconds West, a distance of 466.40 feet to a found 1/2" iron rod with yellow cap stamped "RPLS 4748";

South 18 degrees 38 minutes 50 seconds West, a distance of 1639.94 feet to a found 1/2" iron rod with yellow cap stamped "RPLS 4748" at a corner post at the northwest corner of a 100 acre tract of land to Winston G. Beam, et ux, (FIRST TRACT - 698/858 ORMCT);

THENCE crossing said 22 acre tract, North 67 degrees 46 minutes 13 seconds West, a distance of 232.56 feet to a found 1/2" iron rod with yellow cap stamped "RPLS 4748" at a corner post at the northeast corner of a 78.03 acre tract of land to Howard W. Klement (TRACT ONE - 1106/864 ORMCT, same being the southeast corner of said Leroy Klement TRACT TWO;

THENCE along the west line of said 22 acre tract, same being the east line of said Leroy Klement TRACT TWO, generally along a fence and crossing a pond, North 18 degrees 41 minutes 56 seconds East, a distance of 2092.69 feet to the **POINT OF BEGINNING**, containing 11.12 acres of land.
