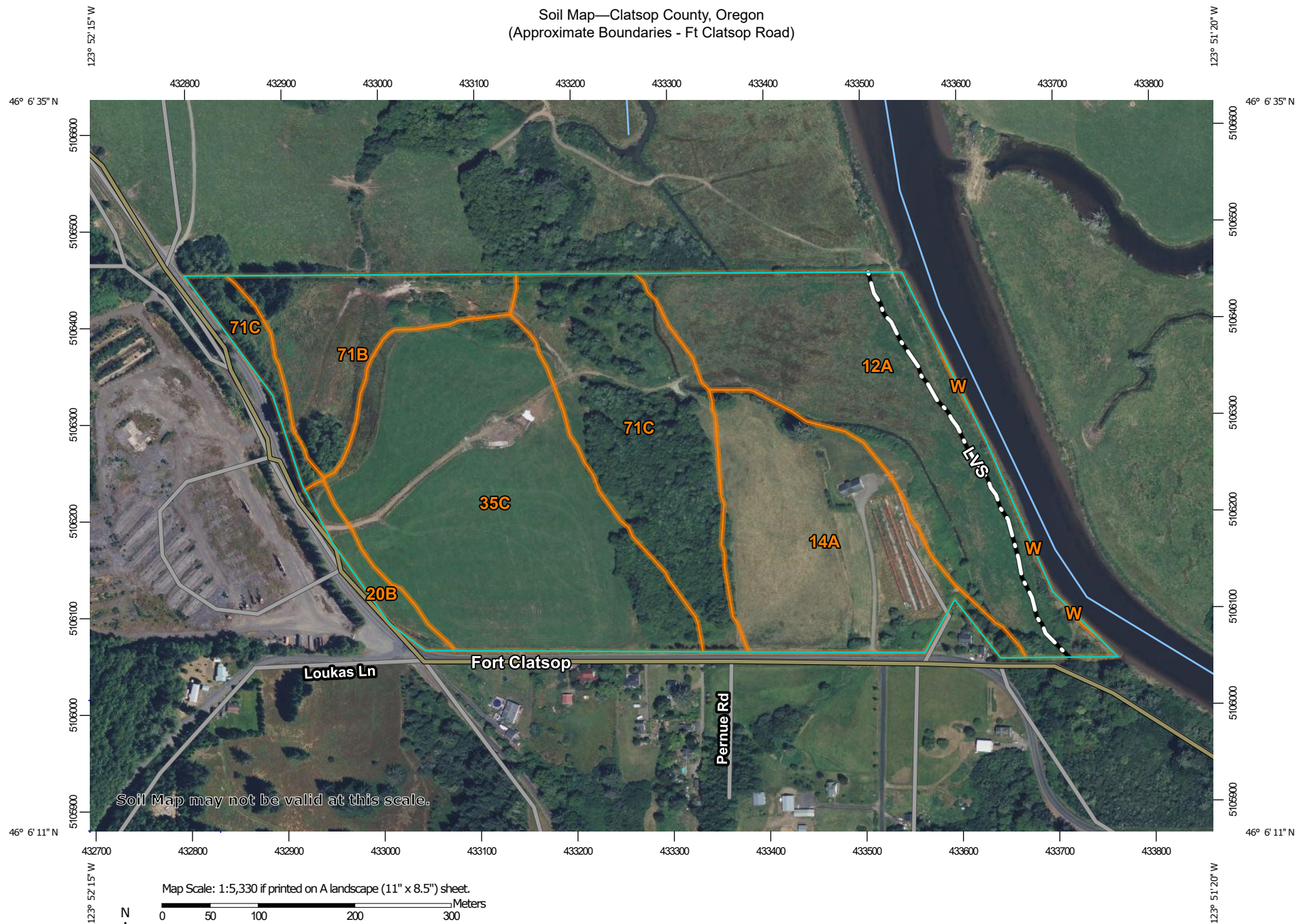


Soil Map—Clatsop County, Oregon
