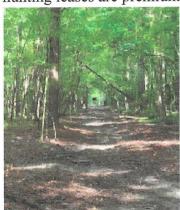

area and pine/hardwood mix. A copy of this timber cruise is available for purchase. The remaining stand of swampland approximately 25+/- acres can be clearcut with suitable logging equipment and favorable dry weather conditions. The stream buffer area along Deep Creek should be marked and select harvested. The timber is mature in today's market and could be harvested if desired, after the timber harvest replant in loblolly pine seedlings at a minimum rate of 484 trees per acre and plant Cypress in the swamp.

This property along with the surrounding area has an abundance of wildlife species such as whitetail deer, wild turkey and waterfowl. The area is known for very high deer density and

hunting leases are premium. There are numerous



trails and tree stands throughout the property, the tree stands do not convey. These shooting lanes and trails have been well maintained by the current lessee.

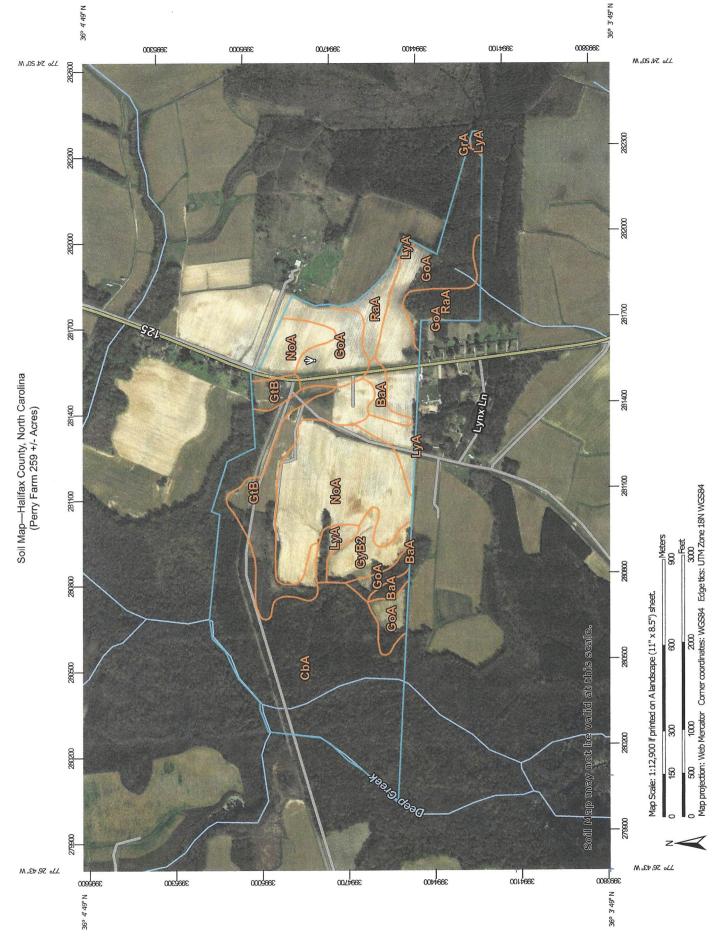
