## FIELD NOTE DESCRIPTION OF A 22.00 ACRE TRACT OF LAND

Being a **22.00** acre tract of land situated in the B. Kuhn Survey No. 898, Abstract No. 819, Comal County, Texas and being out of a called 523.367 acre tract of land-recorded in Volume 330, Page 535, Deed Records, Comal County, Texas, said **22.00** acre tract being more particularly described by metes and bounds as follows:

**BEGINNING** at an iron rod set for the northwest corner of a called 5.001 acre tract of land recorded in Document No. 201506033769, Official Public Records, Comal County, Texas, an interior corner of the above referenced 523.367-acre tract and the northeast corner of the herein described tract;

**THENCE** with an east line of said 523.367 acre tract and the west line of said 5.001 acre tract, **S** 01°00' 53" E, a distance of 599.85' to a 1/2" iron rod found for the northwest corner of a called 5.125 acre tract of land recorded in Document No. 201506033769, Official Public Records, Comal County, Texas, the southwest corner of said 5.001 acre tract, a corner of said 523.367 acre tract and herein described tract;

**THENCE** with east lines of said 523.367 acre tract and west lines of said 5.125 acre tract the following courses and distances:

S 00°23' 02" E, a distance of 172.07' to a 1/2" iron rod found;

and **S 00°44' 57"** E, a distance of **228.46'** to a 1/2" iron rod found for the northwest corner of a called 5.568 acre tract of land recorded in Document No. 200006021625, Official Public Records, Comal County, Texas, the southwest corner of said 5.125 acre tract, a corner of said 523.367 acre tract and herein described tract;

**THENCE** with an east line of said 523.367 acre tract and the west line of said 5.568 acre tract, **S 00°44' 23" E**, a distance of **292.21'** to a 1/2" iron rod found for the common northerly corner of Lots 79 and 80, The Summit North Phase 2 recorded in Volume 13, Page 87-88, Record of Maps and Plats, Comal County, Texas, the westernmost southwest corner of said 5.568 acre tract, the easternmost southeast corner of said 523.367 acre tract and the southeast corner of the herein described tract:

**THENCE** with a southeast line of said 523.367 acre tract and northwest lines of The Summit North Phase 2 the following courses and distances:

S 50°56' 19" W, a distance of 231.12' to a 1/2" iron rod found for the common corner of Lots 79 and 78, The Summit North Phase 2;



and S 50°51' 09" W, a distance of 210.44<sup>+</sup> to a 1/2" iron rod found for the common corner of Lots 78 and 77, The Summit North Phase 2 and the southernmost corner of the herein described tract;

**THENCE** severing said 523.367 acre tract the following courses and distances:

N 28°05' 35" W, a distance of 1226.04' to an iron rod set for the westernmost corner of the herein described tract;

N 48°13' 56" E, a distance of 887.91' to an iron rod set for the northernmost corner of the herein described tract;

and S 66°53' 08" E, a distance of 260.10' to the POINT OF BEGINNING containing 22.00 acres of land.
