


Ransom Free Road Mini-Farm Lots 1,2 Clermont, GA 30527

Lots

1. Lot 1 +/- 15.6 Acres \$390,000 (\$25,000 PER ACRE)

- a. Lot 1 is our Premier Lot with around 1,000 feet of frontage on the beautiful West Fork Little River. This is a great lot with a great potential homesite in pasture overlooking the river. 900 Ft of road frontage on Ransom Free Road with a great view of Wauka Mountain off your front porch.

2. Lot 2 +/- 16.2 Acres \$364,500 (\$22,500 PER ACRE)

- a. Lot 2 is a great lot with around 950 Ft of road frontage on Ransom Free Road with a beautiful hardwood entrance into a potential homesite in pasture. The pasture takes up to around 10 Acres with great hardwood timber towards the front of the tract. This tract also houses the best view of Wauka Mountain and has an old small pond site on the back side of the proposed property line.

Restrictions by Seller

- Cattle Fencing must be placed on southern border of property boundary as owner of southern parcel own cattle.
- Homes built must be stick-built and no less than 1000 Sq Feet.
- All homes or temporary homes must be approved by Hall County.
- Property will be sold SUBJECT TO an existing Conservation Use Valuation Assessment (“CUVA”).
