The Orange Avenue Citrus Growers Assoc. provides irrigation and drainage to the property, through their network of canals, reservoirs, roads, and pumps. The property is ideally situated for replanting citrus or other tree crops and could be easily converted to other uses for numerous other agricultural type uses.
