SMITH SURVEY, ABSTRACT No. 759, both surveys located in Bosque County, and said tract being a 7.73 acre tract of land conveyed by Leon Howard Everett Farr to Chose Colon, a married man, by the General Warranty Deed recorded by Instrument No. 2022—04585 of the Official Public Records of Bosque County, Texas, and being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch iron rod found near the base of a wood fence corner post for the northeast corner of the herein described tract of land, said iron rod found on the northeasterly accepted right—of—way line of County Road No. 1190, said iron rod also being the northwest corner of that certain called 9.584 acre tract of land conveyed to KENT Wallace Betts by the deed recorded by Instrument No. 2022—01794 of the Official Public Records of Bosque County, Texos;

THENCE South 55 degrees 34 minutes 59 seconds West, generally along a fence line and a common line between said Betts tract and said Colon tract, at a distance of 699.74 feet, passing the southwest corner of said Betts tract and said corner also being the northeast corner of that certain called 10.013 acre tract of land conveyed to Bryan Frenzel and wife Kimberly Faye Frenzel by the Instrument No. 2007-04081 of the Official Public Records of Bosque County. Texas, and continuing now along said fence and a common line between said Frenzel tract and said Everett tract, in all a distance of 910.94 feet to a capped (stamped "Davis Surveying") 1/2 inch iron rad found at the base of a wood fence corner post for the southeast corner of the herein described tract of land, said capped iron rad found also being the northeast corner of that certain called 8.005 acre tract of land conveyed to Shannon Bryan Frenzel and Kimberly Foy Frenzel by the Instrument No. 2011-01775 of the Official Public records of Bosque County, Texas;

THENCE North 34 degrees 23 minutes 49 second West, generally along a fence line and a common line between soid Colon tract and said Shannon tract, a distance of 193,05 feet to a capped (stamped "RPLS 5614") 1/2 inch iron rod set for the northwest corner of the herein described tract of land;

THENCE North 55 degrees 25 minutes 17 seconds East, along the northwesterly line of the herein describe tract of land, a distance of 753.31 feet to a capped (stamped "RPLS 5614") 1/2 inch iron rad set for the northeast corner of the herein described tract of land, said capped iron rad set on the southwesterly accepted right-of-way line of County Road No.1190, and northeasterly line of said Colon tract;

Tremonti by the instrument No. 2014—03668 of the Official Public records of Bosque County, Texos;
