- Limits the maximum amount of property tax paid to 3% of total household income, and
- Ensures the amount of tax paid remains the same as long as you participate in this program. To be eligible, you must file an application by **November 1, 2022**, as well as:
 - 1. Be at least 65 years old,
 - 2. Have a household income of \$60,000 or less, and
 - 3. Have lived in your home for at least 15 years.
