South 34° 04' 53" East, 161.38 feet, along the West line of a 15.13 acre tract of land, described in an instrument, recorded in Clerk's File No. 95394, Official Public Records, Wilson County, Texas, said point being an angle point of this tract of land;

South 41° 40' 50" East, 47.44 feet, continuing along the West line of said 15.13 acre tract of land, to a calculated point, said point being an angle point to this tract of land;

South 51° 24' 20" East, 37.54 feet, continuing along the West line of said 15.13 acre tract of land, to a calculated point, said point being an angle point to this tract of land;

South 58° 19' 49" East, 51.19 feet, continuing along the West line of said 15.13 acre tract of land, to a calculated point, said point being the East corner of said 314.05 acre tract of land, a reentrant corner of said 15.13 acre tract of land, said point being the most Easterly corner of this tract of land;

Records, Wilson County, Texas, at 64.85 feet, passing a 1/2 inch steel rod monument, found for an witness point of said remainder of a 314.05 acre tract of land, being a salient corner of said 15.13 acre tract of land, and a salient corner of said 183.35 acre tract of land, in all, a total distance of 1554.01 feet, to a point marked by a 1 inch steel pipe monument, found for the South corner of said remainder of a 314.05 acre tract of land, being the East corner of said 56.69 acre tract of land, said point being the South corner of this tract of land;
