RAGETH FARM

Byron, Big Horn County, Wyoming

The Rageth Farm consists of 1,192± deeded acres with 849 ± pivot-irrigated acres and 44± flood irrigated acres. Nine pivots are supplied water with exceptional senior water rights by the Sidon Irrigation Canal which delivers water from the Shoshone River and Bitter Creek.

LOCATION & ACCESS

The Rageth Farm is located approximately ½ mile west of Byron, Wyoming on US Highway 14A.

Several towns and cities in proximity to the property include:

SIZE & DESCRIPTION

1,192± Total Deeded Acres

The Rageth Farm is located in an area known for exceptional water, high crop yields and its mild climate. Situated at 4,029 feet above sea level, the terrain of the farm is mostly flat making for easy and efficient irrigation.

PIVOT & CROP INFORMATION

There are nine electric pivots on the farm that are in exceptional condition with manual control boxes and separate meters and pumps for each pivot. The pivot, pump and crop information for the pivots are as follows:

In addition to the pivot-irrigated acres, there are 44.4± flood-irrigated acres that are currently in grass/alfalfa hay production.

WATER RESOURCES

The Rageth Farm has some of the very best water rights of any farm within a multi-state region. With senior water rights dating back to 1959 on Bitter Creek and water rights from the Shoshone River dating back to 1900, the farm consistently has an abundance of water over and above what is used.

The Sidon Irrigation Canal delivers water to the farm from Bitter Creek as well as the Shoshone River. The Sidon Irrigation Canal delivery cost for the Shoshone River water is currently \$36.00 per irrigated acre (207 acres). The delivery cost payable to the Sidon Irrigation Canal for the Bitter Creek water is set at 30% of the general assessment which equates to \$13.00 per irrigated acre (709.66 acres).

A very unique feature of the Sidon Irrigation District is that there is an oil royalty payable to its members in September of each year, the details of which will be made available to prospective buyers upon request.

There is one domestic well that serves the home on the farm and a natural spring located on the property that waters livestock throughout the winter months.

RAGETH PIVOT PARCEL OFFERING

The Sellers would be willing to parcel off everything north of the Sidon Canal and sell it separately. The offering would consist of pivots #4-9 and would include approximately 930± deeded acres, pending a survey. There would be 706± pivot irrigated acres in the offering with the vast majority of the water rights being Bitter Creek water rights and approximately 6.7 acres of Sidon water rights. The 2021 electric costs associated with these 6 pivots was \$28,136.85 while the Bitter Creek Water assessment was \$13.00 per irrigated acre. The 60'x60' Morton Equipment Storage shed is located on this parcel and no other structures. The Rageth Pivots are being offered at \$4,292,000.00

CARRYING CAPACITY/RANCH OPERATIONS

With $4\frac{1}{2}$ miles of new perimeter fence, the current owners are able to take in approximately 400 head of mother cows for two months in the winter to graze the aftermath on the pivots and corners. The cattle are able to water at a natural water spring located on the west side of the farm. In 2021, the daily charge per cow was \$1.50.

REAL ESTATE TAXES

According to the Big Horn County Assessor's records, the real estate taxes for the Rageth Farm are approximately \$9,816 annually. In addition, there is a drainage fee assessed in the amount \$1,620.




RECREATION & WILDLIFE

Located in the heart of the Big Horn Basin, Byron was settled in May of 1900 by Mormon pioneers. The Town of Byron is named after Byron Sessions who was the general manager of the Sidon Canal Construction Company. The construction of the canal, which brought irrigation water to the area, is what turned this area into a fertile and productive farming community with substantial oil and gas production. With a population of 593, the residents of Byron are able to enjoy the peace and serenity of small town living just minutes from all the amenities that the college town of Powell, Wyoming has to offer. From grocery shopping and dining to professional services and lodging, the area provides all the services one would expect in college town with a high influx of tourism.

Located in the Big Horn School District # 1, school age children attend school in either Rocky Mountain School in Cowley or Lovell, Wyoming which is a short drive from Byron.


Commercial airline service is available at Cody and Gillette, Wyoming; and Billings, Montana. The following is information on each of these airports:

CLIMATE







STATE LOCATION MAP



REAL ESTATE BROKERAGE DISCLOSURE

When you select a Real Estate Broker Firm, Broker or sales person (all referred to as "Broker") to assist you in a real estate transaction, the Broker may do so in one of several capacities. In accordance with Wyoming's Brokerage Relationships Act, this notice discloses the types of working relationships that are available to you.

Seller's Agent. (Requires written agreement with Seller)

If a Seller signs a written listing agreement with a Broker and engages the Broker as a Seller's agent, the Broker represents the Seller. On properties listed with other brokerage companies, the Broker may work as an agent for the Seller if the Seller agrees to have the Broker work as a subagent. As an agent or subagent for the Seller, the Broker represents the Seller and owes the Seller a duty of utmost good faith, loyalty, and fidelity in addition to the **obligations** enumerated below for Intermediaries. Wyo. Stat. § 33-28-303(a). The Seller may be vicariously liable for the acts of the Seller's Agent or Seller's subagent that are approved, directed or ratified by the Seller.

<u>Customer.</u> (No written agreement with Buyer)

A customer is a party to a real estate transaction who has established no intermediary or agency relationship with any Broker in that transaction. A Broker may work as an agent for the Seller treating the Buyer as a customer or as an agent for the Buyer treating the Seller as a customer. Also when a Buyer or Seller is represented by another Broker, a Broker may work with the other Buyer or Seller as a customer, having no written agreement, agency or intermediary relationship with either party. A Broker working with a customer shall owe no duty of confidentiality to a customer. Any information shared with Broker may be shared with the other party to the transaction at customer's risk. The customer should not tell the Broker any information which the customer does not want shared with the other party to the transaction. The customer should not tell the Broker any information which the customer does not want shared with the other party to the transaction. The Broker must treat the customer honestly and with fairness disclosing all material matters actually known by the Broker. The Broker owes the customer the **obligations** enumerated below for Intermediaries which are marked with asterisks. W.S. § 33-28-310(a).

Buyer's Agent. (Requires written agreement with Buyer)

If a Buyer signs a written Buyer Agency Agreement with a Broker, the Broker will act as an agent for the Buyer. If so, the Broker represents the Buyer and owes the Buyer a duty of utmost good faith, loyalty and fidelity in addition to the **obligations** enumerated below for Intermediaries. The Buyer may be vicariously liable for the acts of the Buyer's Agent that are approved, directed or ratified by the Buyer. As a Buyer's Agent, Wyoming law requires the Broker to disclose to potential Sellers all adverse material facts, which may include material facts regarding the Buyer's financial ability to perform the terms of the transaction. Wyo. Stat. § 33-28-304(c). As a Buyer's Agent, the Broker has duties to disclose to the Buyer certain information; therefore, the Seller should not tell the Broker any information which the Seller does not want shared with the Buyer.

Intermediary. (Requires written agreement with Seller and/or Buyer)

The Intermediary relationship is a non-agency relationship which may be established between a Broker and a Seller and/or a Broker and a Buyer. A Seller may choose to engage a Broker as an Intermediary when listing a property. A Buyer may also choose to engage a Broker as an Intermediary. An Intermediary shall not act as an agent or advocate for any party and shall be limited to providing those services set forth below. Wyo. Stat. § 33-28-305.

As an Intermediary (Non-Agent), Broker will not represent you or act as your agent. The parties to a transaction are not legally responsible for the actions of an Intermediary and an Intermediary does not owe the parties the duties of an agent, including the fiduciary duties of loyalty and fidelity. Broker will have the following **obligations** to you:

- perform the terms of any written agreement made by the Intermediary with any party or parties to the transaction;
- exercise reasonable skill and care;*

- advise the parties to obtain expert advice as to material matters about which the Intermediary knows but the specifics of which are beyond the expertise of the Intermediary;*
- present all offers and counteroffers in a timely manner;*
- account promptly for all money and property the Broker received;*
- keep you fully informed regarding the transaction;*
- obtain the written consent of the parties before assisting the Buyer and Seller in the same real estate transaction as an Intermediary to both parties to the transaction;
- assist in complying with the terms and conditions of any contract and with the closing of the transaction:*
- disclose to the parties any interests the Intermediary may have which are adverse to the interest of either party;
- disclose to prospective Buyers, known adverse material facts about the property;*
- disclose to prospective Sellers, any known adverse material facts, including adverse material facts pertaining to the Buyer's financial ability to perform the terms of the transaction;*
- disclose to the parties that an Intermediary owes no fiduciary duty either to Buyer or Seller, is not allowed to negotiate on behalf of the Buyer or Seller, and may prohibited from disclosing information about the other party, which if known, could materially affect negotiations in the real estate transaction.

As Intermediary, the Broker will disclose all information to each party, but will not disclose the following information without your informed consent:

- the motivating factors for buying or selling the property;
- that you will agree to financing terms other than those offered, or
- any material information about you, unless disclosure is required by law or if lack of disclosure would constitute dishonest dealing or fraud.

Change From Agent to Intermediary - In - House Transaction

If a Buyer who has signed a Buyer Agency Agreement with the Broker wants to look at or submit an offer on property Broker has listed as an agent for the Seller, the Seller and the Buyer may consent in writing to allow Broker to change to an Intermediary (non-agency) relationship with both the Buyer and the Seller. Wyo. Stat. § 33-28-307.

An established relationship cannot be modified without the written consent of the Buyer or the Seller. The Buyer or Seller may, but are not required to, negotiate different commission fees as a condition to consenting to a change in relationship.

<u>Designated Agent.</u> (requires written designation by the brokerage firm and acknowledgement by the Buyer or Seller)

A designated agent means a licensee who is designated by a responsible broker to serve as an agent or intermediary for a Seller or Buyer in a real estate transaction. Wyo. Stat. § 33-28-301 (a)(x).

In order to facilitate a real estate transaction a Brokerage Firm may designate a licensee as your agent or intermediary. The Designated Agent will have the same duties to the Buyer and Seller as a Buyer's or Sell's Agent or Intermediary. The Broker or an appointed "transaction manager" will supervise the transaction and will not disclose to either party confidential information about the Buyer or Seller. The designation of agency may occur at the time the Buyer or Seller enters into an agency agreement with the Brokerage Firm or the designation of agency may occur later if an "in house" real estate transaction occurs. At that time, the Broker or "transaction manager" will immediately disclose to the Buyer and Seller that designated agency will occur.

Duties Owed by An Agent But Not Owed By An Intermediary.

WHEN ACTING AS THE AGENT FOR ONE PARTY (EITHER BUYER OR SELLER), BROKER HAS FIDUCIARY DUTIES OF UTMOST GOOD FAITH, LOYALTY, AND FIELITY TO THAT ONE PARTY. A BROKER ENGAGED AS AN INTERMEDIARY DOES NOT REPRESENT THE BUYER OR THE SELLER AND WILL NOT OWE EITHER PARTY THOSE FIDUCIARY DUTIES. HOWEVER, THE INTERMEDIARY MUST EXERCISE REASONABLE SKILL AND CARE AND MUST COMPLY WITH WYOMING LAW. AN INTERMEDIARY IS NOT AN AGENT OF ADVOCATE FOR EITHER PARTY. SELLER AND BUYER SHALL NOT BE LIABLE FOR ACTS OF AN INTERMEDIARY, SO LONG AS THE INTERMEDIARY COMPLIES WITH

THE REQUIREMENTS OF WYOMING'S BROKERAGE RELATIONSHIPS ACT. WYO. STAT. § 33-28-306(a)(iii).

THIS WRITTEN DISCLOSURE AND ACKNOWLEDGMENT, BY ITSELF, SHALL NOT CONSTITUTE A CONTRACT OR AGREEMENT WITH THE BROKER OR HIS/HER FIRM. UNTIL THE BUYER OR SELLER EXECUTES THIS DISCLOSURE AND ACKNOWLEDGEMENT, NO REPRESENTATION AGREEMENT SHALL BE EXECUTED OR VALID. WYO. STAT. § 33-28-306(b).
