



TRACT 8 - 11.01 ACRES

LEGAL DESCRIPTION: Being 11.01 acres of land out of the J. B. Dupree Survey, Abstract No. 86, Karnes County, Texas and also being a portion of that certain 99.11 acre tract described in Instrument No. 202200000658 of the Official Public Records of Karnes County, Texas; Said 11.01 acre tract being more particularly described as follows and as surveyed under the supervision of Intrepid Surveying & Engineering Corporation in April, 2022:

BEGINNING at a 1/2 inch iron rod set in the southeast line of County Road No. 342 and the northwest line of said 99.11 acre tract for the west corner of said 11.01 acre tract (Tract 9) surveyed this same day by: Intrepid Surveying & Engineering Corporation and a north corner hereof and from which a 5/8 inch iron rod found in the southeast line of County Road No. 342 for the west corner of that certain 1.14 acre tract described in Volume 829, Page 475 of said Official Public Records, a north corner of said 99.11 acre tract and a north corner of said 11.01 acre tract (Tract 9) bears North 44°45'19" East a distance of 54.01 feet;

THENCE over and across said 99.11 acre tract and along the common lines of said 11.01 acre tract (Tract 9), the following 2 courses:

1. South 46°33'53" East a distance of 1752.19 feet to a 1/2 inch iron rod set for an interior corner hereof;
2. North 43°26'07" East a distance of 302.66 feet to a 1/2 inch iron rod set in the southwest line of that certain 190.46 acre tract described in Instrument No. 202100000739 of said Official Public Records and the northeast line of said 99.11 acre tract for a north corner hereof;

THENCE South 46°33'53" East a distance of 1269.19 feet along the southwest line of said 190.46 acre tract and the northeast line of said 99.11 acre tract to point in the north line of that certain 280 acre tract described in Volume 681, Page 672 of said Official Public Records for the southwest corner of said 190.46 acre tract, the southeast corner of said 99.11 acre tract and the southeast corner hereof;


THENCE North 89°48'28" West a distance of 520.60 feet along the north line of said 280 acre tract and the south line of said 99.11 acre tract to a 1/2 inch iron rod set for the southeast corner of said 11.01 acre tract (Tract 6) surveyed this same day by: Intrepid Surveying & Engineering Corporation and the southwest corner hereof;

THENCE North 46°33'53" West a distance of 2643.40 feet over and across said 99.11 acre tract and along the northeast lines of said 11.01 acre tract (Tract 6) and that certain 11.01 acre tract (Tract 7) surveyed this same day by: Intrepid Surveying & Engineering Corporation to a 1/2 inch iron rod set in the southeast line of County Road No. 342 and the northwest line of said 99.11 acre tract for the north corner of said 11.01 acre tract (Tract 7) and the west corner hereof;

THENCE North 44°45'19" East a distance of 54.01 feet along the southeast line of County Road No. 342 and the northwest line of said 99.11 acre tract to the **POINT OF BEGINNING** containing 11.01 acres more or less, and as shown on certified plat herewith.

Note: Bearings, distances and acreage shown hereon are NAD 83, South Central Zone and are derived from GPS techniques. Iron Rods set are a 1/2 inch rod with plastic caps marked "INTREPID".
