Miller et ux as recorded under Clerk's File Number 201907851 of said Official Public Records and continuing a total distance of 920.25 feet to point for the southwest corner of this tract on the east side of Mimosa Road, from which a 5/8 inch iron pipe found bears South 89°39'09" East a distance of 1.53 feet and a ½ inch iron rod with cap (Taylor) found bears South 02°28'46" East a distance of 0.28 feet;

THENCE North 02°28'46" West along a west line of this tract and a west line of said 11.876 acre tract a distance of **25.06 feet** to a ½ inch iron rod with cap (Gatons RPLS 6265) found for a northwest corner of this tract and the southwest corner of said 1.875 acre tract;

THENCE South 89°37'11" East along a north line of this tract and the south line of said 1.875 acre tract a distance of **155.20 feet** to a ½ inch iron rod with cap (Gatons RPLS 6265) found for an ell corner of this tract and the southeast corner of said 1.875 acre tract;
