


Regional Map



Wetlands Map







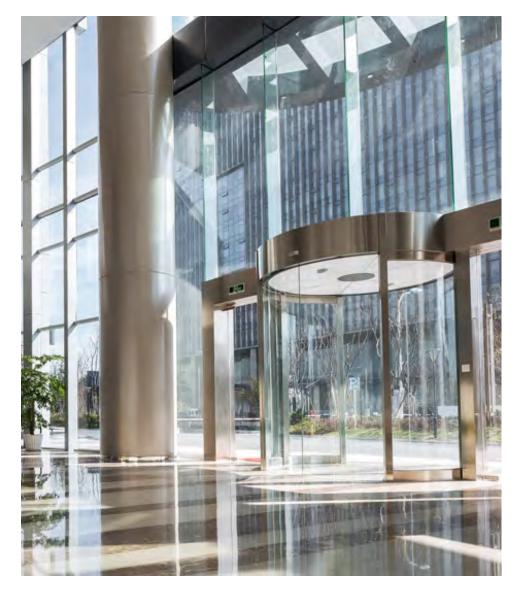
