Thence, along the line common to said 43.25 acre tract and said 14.89 acre tract, North 89 degrees 43 minutes 32 seconds East, a distance of 595.48 feet to a 3/4-inch iron rod found at southeast corner of said 14.89 acre tract, being the southwest corner of a called 10.280 acre tract recorded in the name of William W. McMullen and Mary A. McMullen in H.C.C.F. No. 2010-10031244, for the northwest corner of a called 20.035 acre tract recorded in the name of William McMullen in H.C.C.F.
