I hereby certify that in full compliance with the provisions of Chapter 236.34 of the Wisconsin Statutes and the subdivision regulations of the County of Dane, and by the direction of Kyle Klawitter, owner, I have surveyed, divided and mapped the lands described hereon, and that such map correctly represents the exterior boundaries of the lands surveyed and the division of that land, and that this land is located within and more fully described to wit:

Part of the NW ½ of the SE ½ of Section 23, T.7N., R.11E., Town of Cottage Grove, Dane County, Wisconsin, being more fully described as follows:

Commencing at the East ½ corner of Section 23; thence S89°29'04"W, 1328.73 feet to a 1" diameter iron pipe found at the Northeast corner of the NW ½ of the SE ½ and the point of beginning; thence S00°16'38"W, 1297.08 feet to the North line of Hubred Lane; thence S89°37'22"W along said North line, 360.46 feet to an iron pipe found at the point of curvature of a curve to the left, said curve having a central angle of 166°24'14" and a radius of 60.00 feet, the long chord of which bears S77°05'17"W, 119.16 feet; thence Westerly along the arc of said curve and North line, 174.26 feet to the point of curvature of a curve to the right, said curve having a central angle of 44°50'34" and a radius of 60.00 feet, the long chord of which bears N02°42'41"E, 45.77 feet; thence Northerly along the arc of said curve, 46.96 feet; thence N64°52'02"W, 612.30 feet; thence N25°07'58"E, 270.34 feet; thence N13°46'51"W, 791.85 feet to the North line of the NW ½ of the SE ½; thence N89°39'52"E, 1108.86 feet to the point of beginning. The above described containing 28.047 acres, or 1,221,726 square feet, being subject to the dedication for Hubred Lane as mapped hereon.
