MARCUS BRYAN WILSON, acting as Executor of the Estate of Mitchell B. Wilson, deceased, and MARCUS BRYAN WILSON and spouse, STEPHANIE B. WILSON, hereinafter Grantor, to MARCHALL RONNIE HAWKINS and spouse, DIONE T. HAWKINS, hereinafter Grantee, of Rockingham County, North Carolina, whose address is 160 Ellington Road, Reidsville, NC 27320.

WITNESSETH:

THAT WHEREAS, Mitchell B. Wilson and spouse, Dorothy S. Wilson acquired the real property described hereinafter in Deed Book 1171, Page 695, and Deed Book 832, page 646, Rockingham County Registry, and Dorothy S. Wilson predeceased Mitchell B. Wilson; and

WHEREAS, Mitchell B. Wilson, late of Rockingham County, North Carolina, died testate on July 30, 2020, leaving a Will and Codicil which have been probated in the office of the Clerk of Superior Court of Rockingham County, Estate No. 20-E-622; and

WHEREAS, the Will of Mitchell B. Wilson devised the real property hereinafter described to his son, John Marcus Wilson, and grandson, Marcus Bryan Wilson; and

WHEREAS, John Marcus Wilson has executed and filed with the Clerk of Superior Court of Rockingham County, North Carolina, a Renunciation and Qualified Disclaimer of Residuary Estate, disclaiming and renouncing his interest in all real and personal property bequeathed to him under the Will of Mitchell B. Wilson; and

WHEREAS, Marcus Bryan Wilson qualified as Executor of the Estate of Mitchell B. Wilson on August 31, 2020 before the Clerk of Superior Court of Rockingham County, Estate No. 20-E-622; and

WHEREAS, the Notice to Creditors of the Estate of Mitchell B. Wilson was first published on September 3, 2020; and

WHEREAS, the said Marcus Bryan Wilson, acting as Executor of the Estate of Mitchell B. Wilson has made provision for payment of the debts of the decedent and will make provision for the payment of all administration expenses; and

WHEREAS, less than two (2) years have passed since the death of the said Mitchell B. Wilson.
