THAT, WHEREAS, the parties hereto are owners of contiguous parcels of land located in Big Creek Township, Stokes County, North Carolina, situated on Old Dearmin Road (unpayed) and New Dearmin Road (payed S.R. 1212);

AND, WHEREAS, the property owned by the Grantees, Ronnie Thomas Pack and wife, Sonya Kay Pack, does not adjoin New Dearmin Road (S.R. 1212) but does adjoin Old Dearmin Road;

AND, WHEREAS, the Parties of the First Part, for a favorable consideration, have agreed to grant unto Ronnie Thomas Pack and wife, Sonya Kay Pack, their beirs and assigns, the non-exclusive perpetual easement hereinafter described;

NOW, THEREFORE, in consideration of the foregoing and other good and valuable considerations, receipt whereof is hereby acknowledged, the Parties of the First Part, Grantors, give, grant and convey unto the Parties of the Second Part, Grantees, the non-exclusive perpetual easement more particularly described as follows:

A 30-foot right of way and easement extending from the intersection of Old Dearmin Road and New Dearmin Road in an easterly direction to the southeastern corner of the property of the Grantees, Ronnie Thomas Pack and Sonya Kay Pack, as reflected on a survey plat prepared by C. Phil Wagoner, RLS 1-2416, a copy of which is attached hereto marked Exhibit A, and incorporated herein by reference.

The Parties of the First Part, Grantors, reserve unto themselves the right to use the above described ensement in common with the Parties of the Second Part, Grantors, and said easement shall be appurtenant to and run with the land of the Grantees, their heirs and assigns.

TO HAVE AND TO HOLD the non-exclusive perpetual easement and right of way herein granted unto the said Grantees and their heirs and assigns forever.
