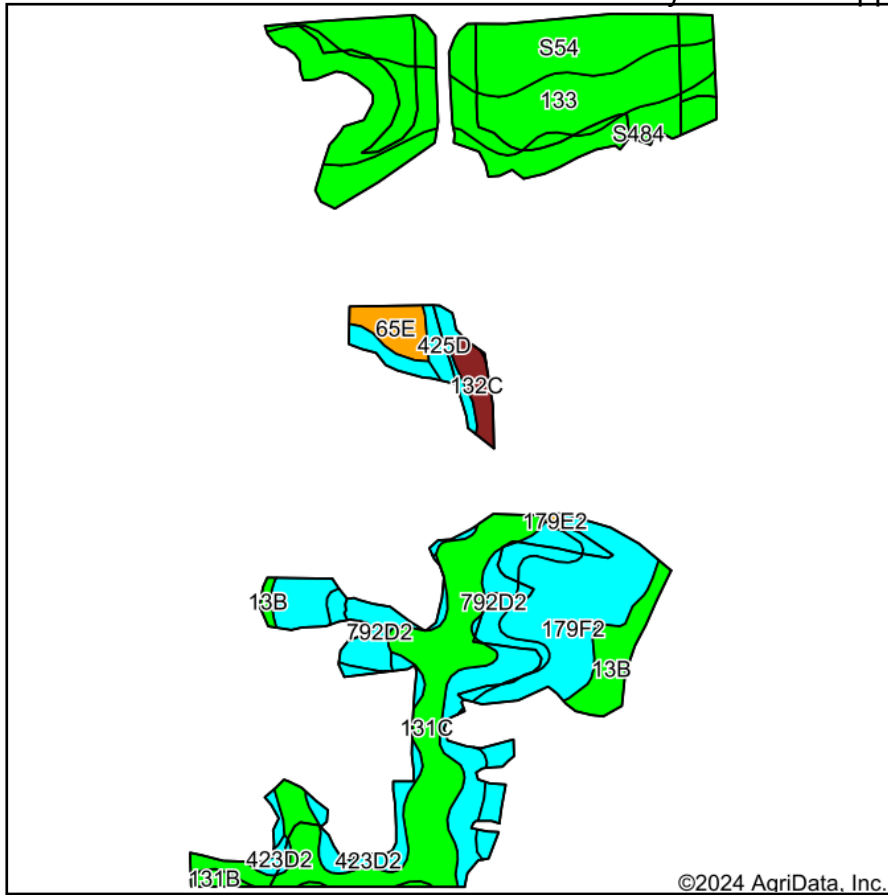
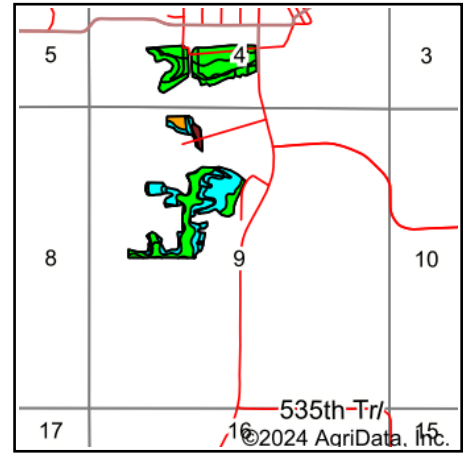


# Soils Map
