METES AND BOUNDS DESCRIPTION OF A 1.500 ACRE TRACT OF LAND KNOWN AS TRACT NO. 2 OUT OF AND A PART OF THAT CALLED 9.075 ACRE TRACT OF LAND DESCRIBED IN DEED TO JAMES G. HUMMEL RECORDED IN VOLUME 1889, PAGE 394 OF THE OFFICIAL RECORDS OF WASHINGTON COUNTY, TEXAS (O.R.W.C.,TX) AND SITUATED IN THE HORATIO CHRISMAN SURVEY, ABSTRACT NO. 24 AND IN THE SAMUEL M WILLIAMS SURVEY, ABSTRACT NO. 109 IN WASHINGTON COUNTY, TEXAS. SAID 1.500 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at a set 5/8 inch iron rod with cap stamped "RPLS 6229" in the east line of said 9.075 acre tract and in the west right of way line of Affleck Road marking the southeast corner of the herein described tract from which a found 1/2 inch iron rod marking the southeast corner of said 9.075 acre tract bears South 03 degrees 06 minutes 04 seconds East 80.11 feet;

Thence on, over and across said 9.075 acre tract the following two (2) courses:


1. **South 89 degrees 56 minutes 04 seconds West 80 feet** north of and parallel to the south line of said 9.075 acre tract **246.68 feet** to a set 5/8 inch iron rod with cap stamped "RPLS 6229";
2. **North 01 degrees 46 minutes 37 seconds West 262.01 feet** to a set 5/8 inch iron rod with cap stamped "RPLS 6229" marking the northwest corner of the herein described tract and the southwest corner of a called 1.500 acre tract of land known as Tract No. 1 this day surveyed;

Thence continuing on, over and across said 9.075 acre tract with the south line of said Tract No. 1 **North 86 degrees 53 minutes 56 seconds East 240.28 feet** to a set 5/8 inch iron rod with cap stamped "RPLS 6229" in the east line of said 9.075 acre tract and the west right of way line of Affleck Road marking the northeast corner of the herein described tract and the southeast corner of said Tract No. 1 from which a found 1/2 inch iron rod marking the northeast corner of said 9.075 acre tract bears North 03 degrees 06 minutes 04 second West 330.81 feet;

Thence with the east line of said 9.075 acre tract and the west right of way line of Affleck Road **South 03 degrees 06 minutes 04 seconds East 275.00 feet** to the **POINT OF BEGINNING** of the herein described tract and containing 1.500 acres within these metes and bounds.
