THENCE along the north line of said 60.30 acres, being an upper south line of said 2397.14 acres and being the south line of said 203.6 acres, N88°16'34"E, 1028.31 feet to a ½ inch iron rod found for the northeast corner of said 60.30 acres, being an upper south ell corner of said 2397.14 acres, being the southeast corner of said 203.6 acres and being in the west line of that certain 25.13 acre tract of land described in Clerks Document No. 201400958 of the Official Public Records of said County;

THENCE along the east line of said 60.30 acres, being the east line of said 2397.14 acres and being the west line of said 25.13 acres, S01°21'34"E, 648.93 feet to a ½ inch iron rod found for the southwest corner of said 25.13 acres, being the northwest corner of that certain 25.10 acre tract of land described in Clerks Document No. 201400958 of the Official Public Records of said County;
