

# **DESCRIPTION:**

Commence at a concrete monument at the NW corner of the SW 1/4 of Section 8, T17N, R25E, Macon County, Alabama; thence South 00 degrees 48 minutes 01 seconds East, along the west line of Section 8, 1375.37 feet; thence North 89 degrees 56 minutes 34 seconds East, 837.63 feet to an iron pin on the east right of way of U.S. Highway 29, R.O.W. varies; thence leaving said right of way, South 50 degrees 21 minutes 22 seconds East, 517.55 feet to an iron pin, said point being the POINT OF BEGINNING; thence continue South 50 degrees 21 minutes 22 seconds East, 1144.26 feet to an iron pin in centerline of creek/branch; thence southerly, along centerline of said creek/branch, the following three (3) calls: 1) South 15 degrees 36 minutes 58 seconds East, 33.50 feet; 2) South 53 degrees 45 minutes 43 seconds West, 95.96 feet; 3) South 28 degrees 56 of Section 8; thence South 88 degrees 56 minutes 07 seconds West, along said section line, 590.90 feet to an iron pin; thence South 89 degrees 08 minutes 50 seconds West, 12.52 feet to an iron pin on the north right of way of U.S. Highway 80, R.O.W., varies; thence North 67 degrees 28 minutes 11 seconds West, along said right of way, 475.70 feet to a concrete monument; thence South 22 degrees 18 minutes 30 seconds West, along said right of way, 25.03 feet to a concrete monument; thence North 67 degrees 28 minutes 26 seconds West, along said right of way, 545.67 feet to a painted "X" on concrete flume; thence leaving said right of way, North 22 degrees 31 minutes 34 seconds East, 499.33 feet to an iron pin; thence South 83 degrees 43 minutes 33 seconds East, 660.38 feet to an iron pin; thence North 01 degrees 01 minutes 00 seconds East, 270.16 feet to the point of beginning.


