

Now, WHEREAS, the Declarant hereby agrees that the following covenants are agreed upon by both parties and run with the land in perpetuity:

- Land use: Residential only; equine, bovine or show animal use is permitted; this includes storage
 of personal owned vehicles, equipment. Such items shall be stored and the rear of the primary
 residence.
- All commercial uses are prohibited as well as storage of supplies and equipment for business/commercial purposes.
- Manufactured housing and mobile homes are not permitted. Temporary, bolt-erected carports or permanent shipping containers are not permitted.
- Aerobic or field septic systems are required.
- Front Setback from Right of Way shall be 200°.
