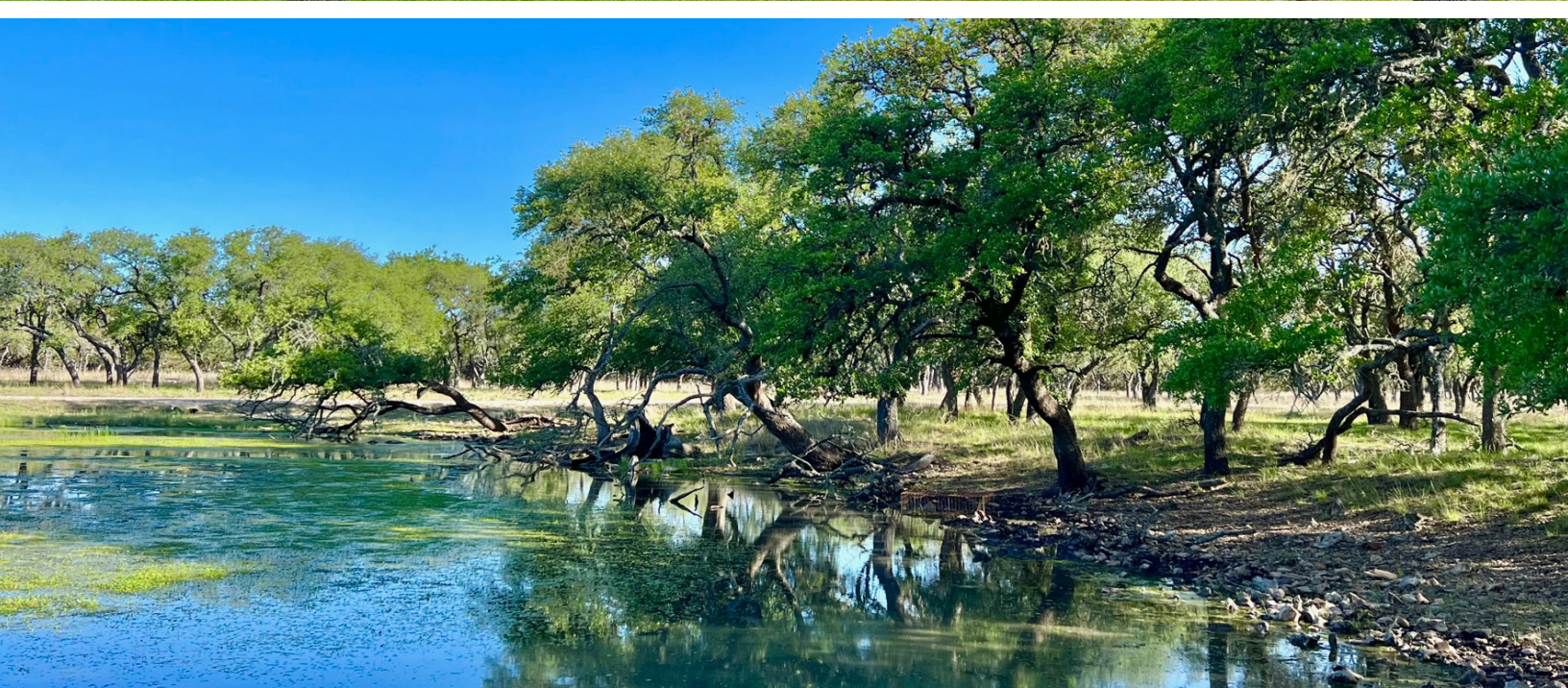


MI CIELO RANCH

DESCRIPTION

In Spanish, mi cielo means My Heaven. When you see this ranch for the first time, you will understand exactly how it got its name!

Hidden two minutes off scenic Ranch to Market 187 in deep southwest Kerr County, this rare and pristine offering of 688 dazzling acres literally defines the word privacy. The property is completely high-fenced, and it is surrounded by three neighbors whose ranchlands sprawl across almost 9,000 acres of stunning Hill Country. Mi Cielo is only one and a half hours to San Antonio and less than an hour from Kerrville and Uvalde. The ranch also enjoys paved highway frontage only ten minutes north of the pristine Lost Maples State Natural Area, and it is only 15 minutes west of a true Texas summer tradition, Crider's Rodeo & Dancehall. The terrain of Mi Cielo consists of gently rolling hills, blanketed in an unbelievable number of oak trees, interspersed with lush verdant meadows. Shallow dry-creek drainages fall in multiple directions from the elevated center of the property and eventually wander off the ranch. Decades of dedicated brush management practices have left the entire landscape covered in strong native grasses with cedar found only in selected areas. The stewardship of this awesome ranch has obviously been a multi-decade labor of love.

The wildlife population at Mi Cielo is strong and diverse, and includes whitetail deer, turkey, dove, wild hogs, blackbuck antelope, axis deer and an amazing variety of varmints. There are three fabulous hunting locations currently set up on the ranch, each equipped with very nice blinds and brand-new corn feeders surrounded by hog panels.

Power is on-site, and there are three solar water wells with storage tanks and water troughs already in place. The seller will convey all mineral and executive rights owned to buyer at closing.

Information About Brokerage Services

11-2-2015

Texas law requires all real estate license holders to give the following information about brokerage services to prospective buyers, tenants, sellers and landlords.

TYPES OF REAL ESTATE LICENSE HOLDERS:

- **A BROKER** is responsible for all brokerage activities, including acts performed by sales agents sponsored by the broker.
- **A SALES AGENT** must be supervised by a broker to perform any services and works with clients on behalf of the broker.

A BROKER'S MINIMUM DUTIES REQUIRED BY LAW (A client is the person or party that the broker represents):

- Put the interests of the client above all others, including the broker's own interests;
- Inform the client of any material information about the property or transaction received by the broker;
- Answer the client's questions and present any offer to or counter-offer from the client; and
- Treat all parties to a real estate transaction honestly and fairly.

A LICENSE HOLDER CAN REPRESENT A PARTY IN A REAL ESTATE TRANSACTION:

- **AS AGENT OR SUBAGENT FOR OWNER (SELLER/LANDLORD):** The broker becomes the property owner's agent through an agreement with the owner, usually in a written listing to sell or property management agreement. A subagent represents the owner, not the buyer, through an agreement with the owner's broker. An owner's agent must perform the broker's minimum duties above and must inform the owner of any material information about the property or transaction known by the agent, including information disclosed to the agent or subagent by the buyer or buyer's agent.
- **AS AGENT FOR BUYER/TENANT:** The broker becomes the buyer/tenant's agent by agreeing to represent the buyer, usually through a written representation agreement. A buyer's agent must perform the broker's minimum duties above and must inform the buyer of any material information about the property or transaction known by the agent, including information disclosed to the agent by the seller or seller's agent.
- **AS AGENT FOR BOTH - INTERMEDIARY:** To act as an intermediary between the parties the broker must first obtain the written agreement of *each party* to the transaction. The written agreement must state who will pay the broker and, in conspicuous bold or underlined print, set forth the broker's obligations as an intermediary. A broker who acts as an intermediary:
 - Must treat all parties to the transaction impartially and fairly;
 - May, with the parties' written consent, appoint a different license holder associated with the broker to each party (owner and buyer) to communicate with, provide opinions and advice to, and carry out the instructions of each party to the transaction.
 - Must not, unless specifically authorized in writing to do so by the party, disclose:
 - that the owner will accept a price less than the written asking price;
 - that the buyer/tenant will pay a price greater than the price submitted in a written offer; and
 - any confidential information or any other information that a party specifically instructs the broker in writing not to disclose, unless required to do so by law.

TO AVOID DISPUTES, ALL AGREEMENTS BETWEEN YOU AND A BROKER SHOULD BE IN WRITING AND CLEARLY ESTABLISH:

- The broker's duties and responsibilities to you, and your obligations under the representation agreement.
- Who will pay the broker for services provided to you, when payment will be made and how the payment will be calculated.
