Peoples Company is pleased to present a unique opportunity to acquire a high-quality tillable farm near Redfield in Dallas County, Iowa. The farm is located in Section 3 of Union Township in a strong farming area. The farm is located east of Redfield, Iowa on paved Old Highway 6 and gravel 310th Trail and consists of 152.08 acres m/l subject to survey, with approximately 139.98 m/l tillable acres, carrying an excellent CSR2 of 86. Primary soil types on the tillable acres include high-producing Clarion loam and Webster clay loam.

There are multiple areas of the farm seeded down to waterways to prevent soil erosion and allow surface water to exit the farm through one of the multiple outlets located throughout. There is existing drainage tile throughout the property. The farm underwent cleanup efforts in February of 2024 including clearing trees and trimming the waterways. The farm is open for 2025.

The farm has direct access to Interstate 80 from Old Highway 6, being 4.5 miles directly north of the Exit 100 on-ramp to Interstate 80. This farm is located within the West Central Valley School District, only 10 minutes west of Adel, Iowa, and less than 20 minutes west of Waukee, Iowa.

The city of Redfield boasts activities for everyone to enjoy like the Raccoon River Valley bike trail, annual town events to celebrate their history, and interesting geological features like Hanging Rock Park. A building site will be surveyed off the farm by the Seller. This site would be the perfect place to build a home near the Des Moines Metro with no covenants or restrictions.
