This property features a gently rolling terrain and an incredible amount of mature timber with cedar thickets, ridgetop and creek bottom clearings for food plots, enclosed elevated hunting blind, and a newly constructed lake with fishing and swimming dock. A 2020 timber appraisal estimated the property contains 795,862 board feet of hardwood sawtimber valued at over \$100,000 at that time. There is an extensive and well-maintained trail system throughout the property that can accommodate your ATV or even pickup. There are also miles of gravel county roads surrounding the property to explore.

The acreage includes a newly constructed, nicely finished 2-bed / 1-bath cabin featuring a large living room / dining area, full kitchen, storage/mechanical room, electric base-
