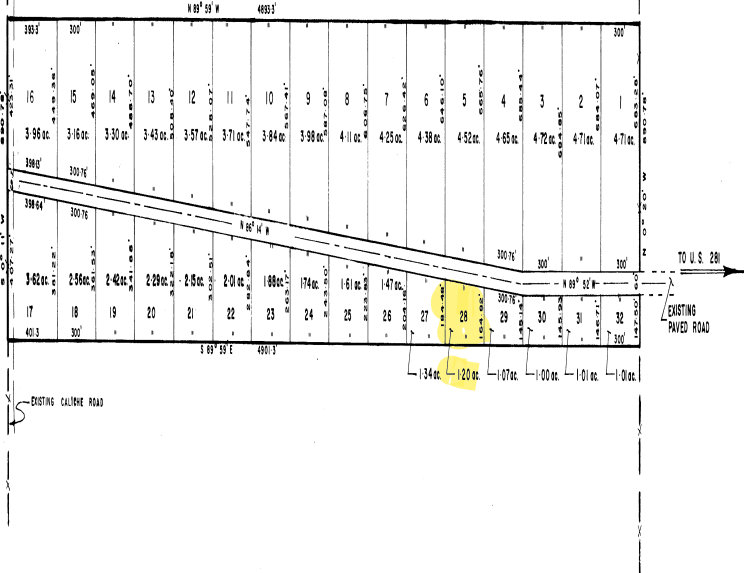

AMARGOSA SUBDIVISION

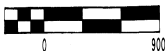
