That TWO COUNTY CORP., a Texas corporation, being the owner of T-C ACRES, SECOND INSTALLMENT, a subdivision in Leon County, Texas, as shown on a plat of said subdivision recorded in Volume 44, Page 84, Plat Records of Leon County, Texas, does hereby impress all of the lots included in such subdivision with the following restrictions which shall constitute covenants running with the land, to-wit:

1. No noxious or offensive activity shall be carried on upon any lot or tract, nor shall anything be done thereon that may be or may become an annoyance or nuisance to the neighborhood.
2. Disposition of human excreta and other sewage shall be by sewer facilities as licensed by the Brazos River Authority and built in accordance with the latest standards and criteria established by the Texas Department of Health.
3. No portion of the property shall be used for any purpose other than residential or non-commercial recreation.
4. No lot shall be used for any commercial purpose or in connection with any commercial, professional or business activity to which the general public is invited.
