





CSWR-Texas Update



- Acquired/under contract: 106 water and 24 wastewater systems since December 2020.
- Have performed internal audits on 100% of our facilities in 2022
- Temporary Emergency Manager for Aero Valley, Farrar & Castlecomb
 - Aero Valley Water system serving ~40 connections that was previously under BWA for 2+ years
 - Farrar Water system serving ~15 homes where a customer was paying for operations expenses out of pocket
 - Castlecomb Water & wastewater system serving 27 homes that was previously releasing untreated sewage in Guadalupe River
- Emergency Operator for Circle R water system in Tarrant County serving 45 homes
- Winter Storm Irma Response (2021)
 - Responded within 24 hours of storm passing on 23 water systems serving over 2,500 connections many of which had been owned for less than 60 days.
 - During this time CSWR-TX recorded 5,000 service calls and restored service at all but one plant within 48 hours.

- CSWR-TX continues to actively pursue the acquisition of distressed water and wastewater systems throughout Texas.
- As emerging drinking water containments are identified and regulated, new permits issued, and additional limits are imposed on WWTPs across the state, CSWR-TX will be a partner to communities to ensure compliance with increased regulation at a reasonable cost to customers.
