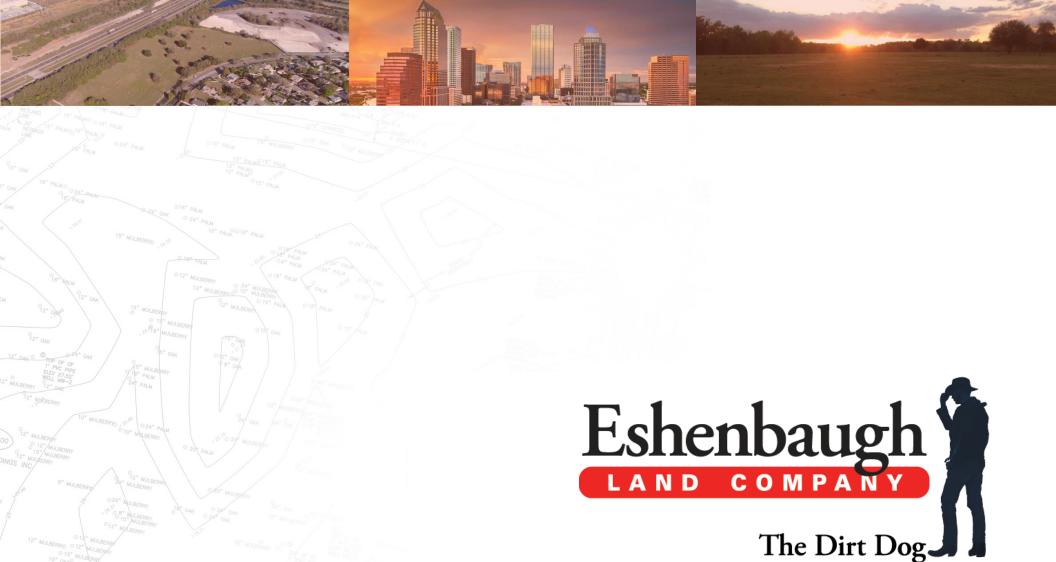

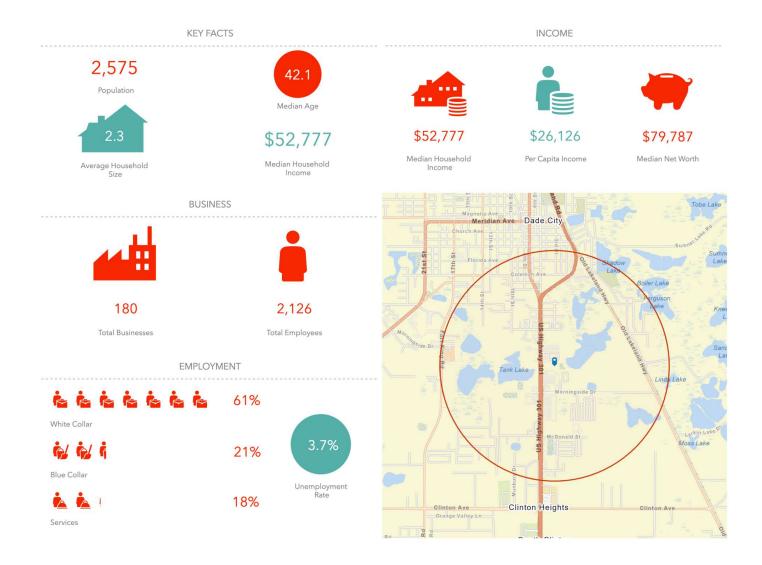

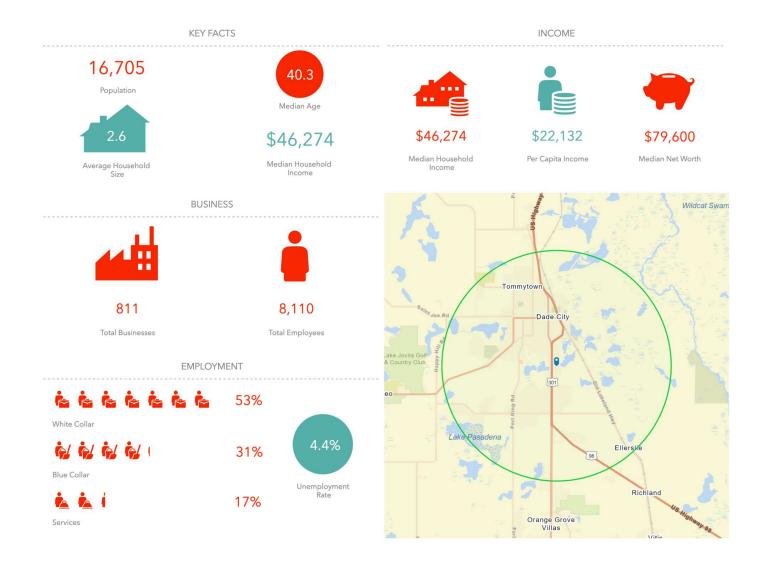


### Demographics - 1 Mile Radius



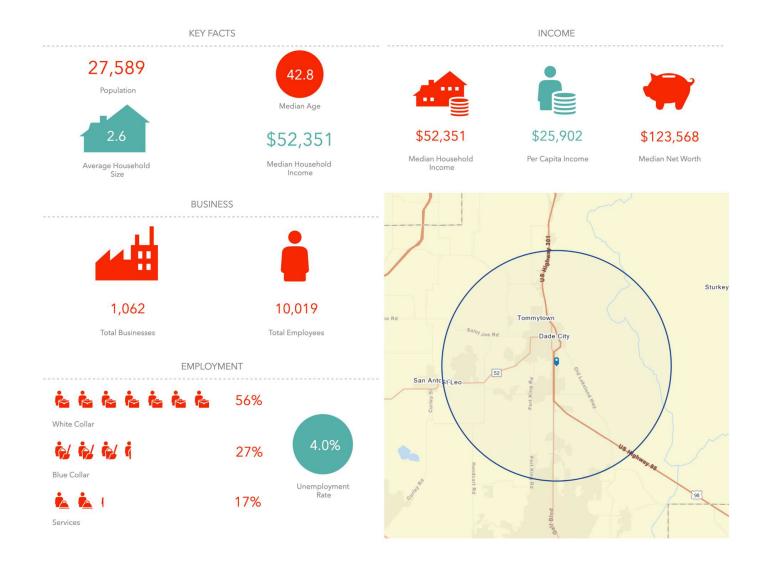


### Demographics - 3 Mile Radius

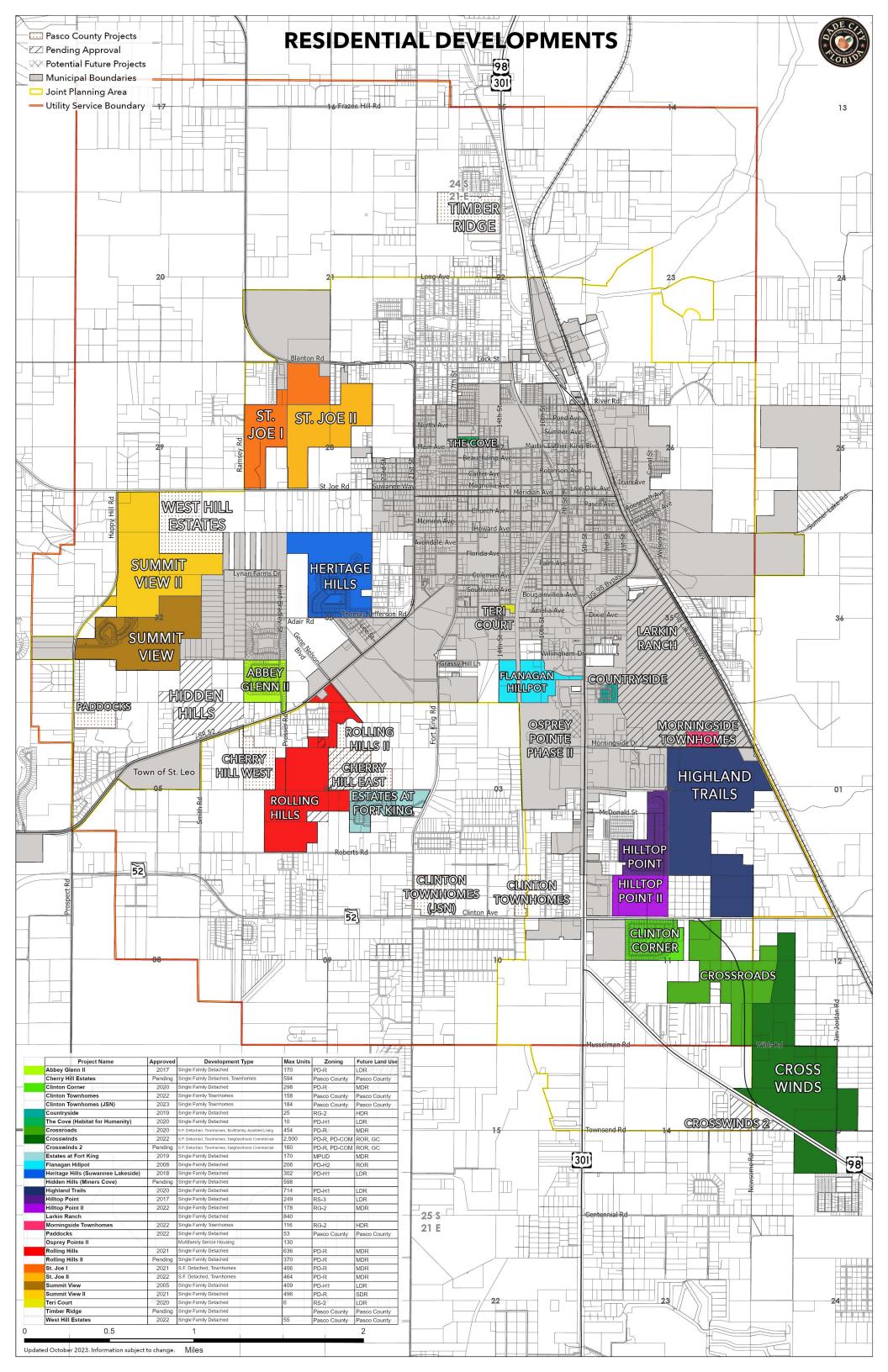




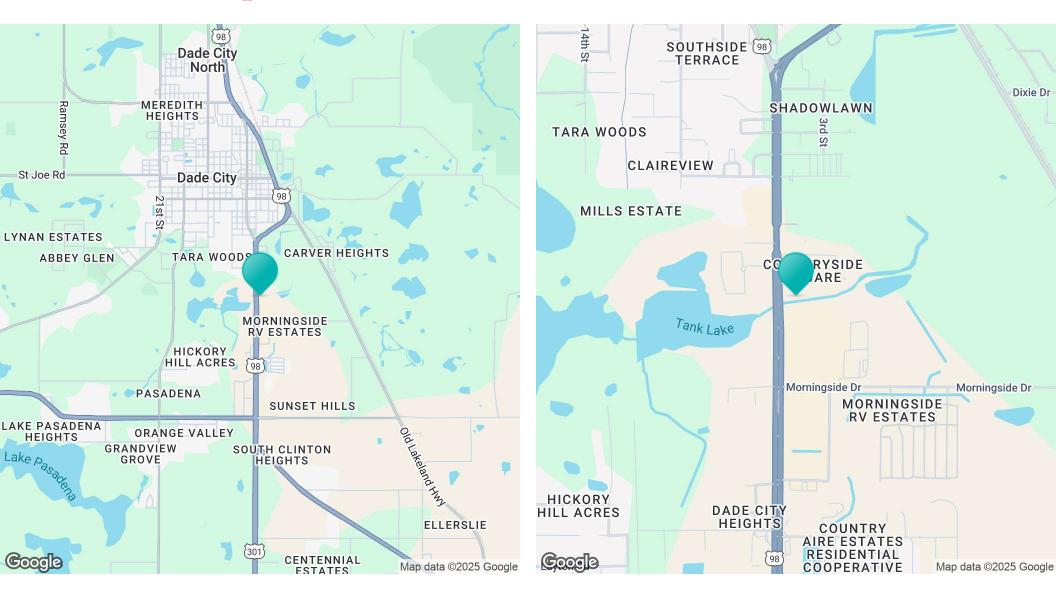
### Demographics - 5 Mile Radius
