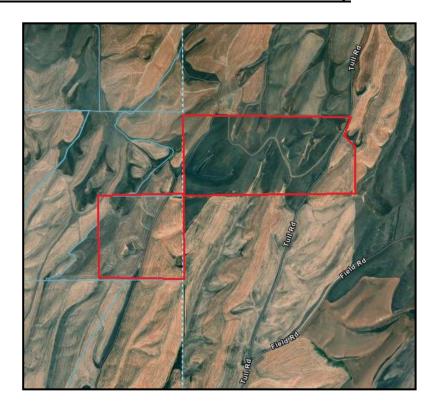
#### PROPERTY DESCRIPTION

Associated Appraisers of Walla Walla, LLC is pleased to present the offer for sale a property located north of Prescott in Walla Walla and Columbia Counties.

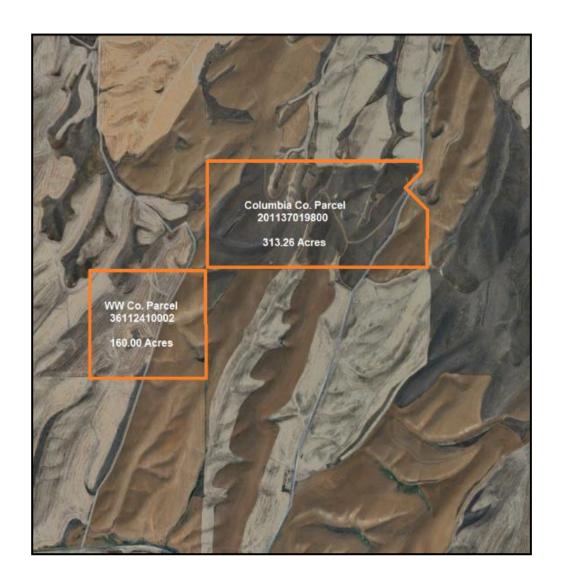
This farm is located about 10 miles northeast of Prescott along the east and west sides of Tull Road, it has a total of **473.26 acres** of which there are **419.83 tillable acres**. The farm currently has **233.84 CRP acres**, with a contract expiration date of 2026. The CRP payment is based on \$84.13 per acre, or \$19,673 per year, and the tillable acres are leased for \$9,300 per year.

The tract is provided access from county-maintained, gravel Tull Road. The irregular shaped tract is sloping to steep in topography with elevations ranging from 1,780 feet along the county line and rises up to 1,900 feet above sea level along the ridge tops of the northern area. The predominant soil type is Walla Walla silt loam, 8 to 30 percent slopes. The average annual rainfall is 15 to 16 inches. Power is available to the tract. The historic winter wheat yield is 85 bushels per acre on a winter wheat/summer fallow rotation.

#### Walla Walla and Columbia Counties Aerial Parcel Map

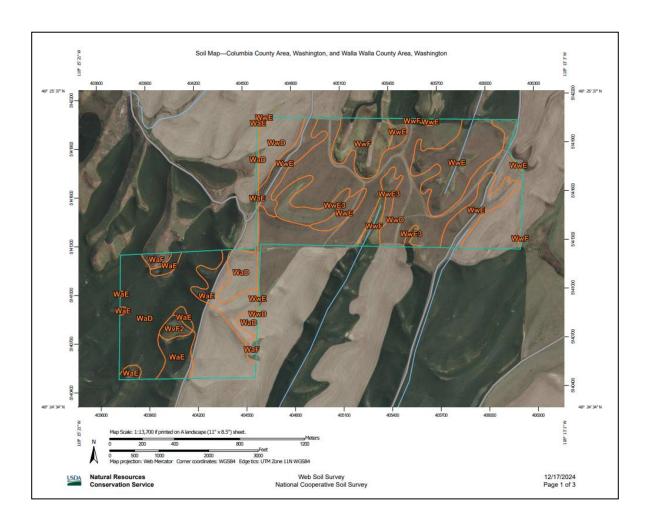

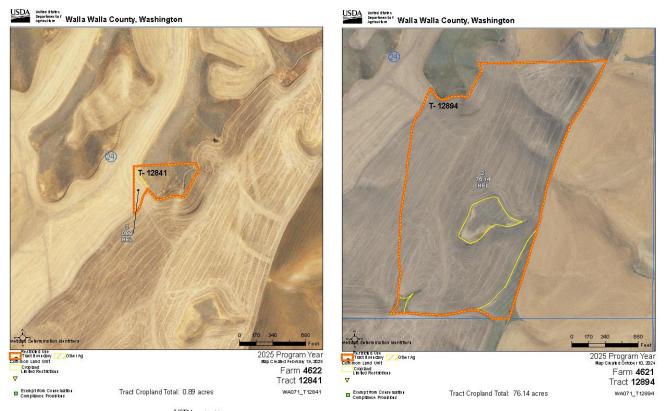
#### **Soils**

#### FSA Aerial Maps - Walla Walla County Parcel

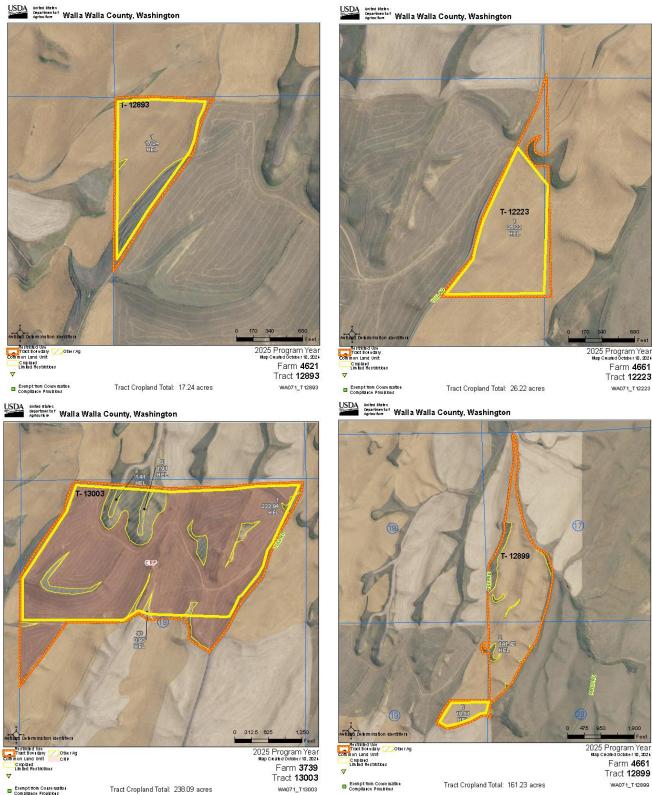
Portion noted in red on the bottom map is outside of the parcel.

Portions inside of the parcel are outlined in yellow.





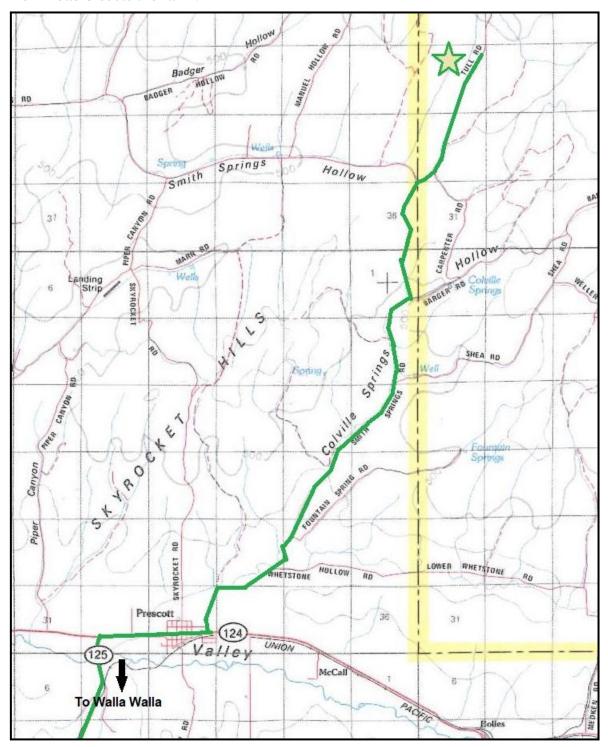
Facing North on Tull Road – Subject Farm is on Both Sides of the Road
