he L River Bottoms is a proven duck hunting property consisting of approximately 434.0 +/surveyed acres on the L'Anguille River in Cross County, just west of Cherry Valley, Arkansas.

Access to the land is excellent, with multiple entry points from Cross County Road 210,
including a private boat ramp and deeded access on the south side of the property.

The land sits on the prominent L'Anguille River waterfowl flyway, benefiting from consistent duck traffic migrating between other quality habitats up and down the river. The L'Anguille River runs directly through the property, providing over two and a half miles of river frontage. The extensive flooded land makes the hunting areas feel much larger than the actual acreage.

The property features a diverse hunting habitat, including timber holes, a willow hole, buckbrush sloughs, and approximately 140.0 +/- acres of cropland suitable for cultivating duck food plots. This 140-acre field (known as the "DU Field") offers a levee system and water control structures and serves as a sanctuary for ducks in the adjacent area. There are seven established duck blinds, with three positioned to allow daily hunting without interference between groups.

Historical hunting success on the land is outstanding, with harvest data showing 1,700 ducks bagged during the 2024-2025 season and 1,900 ducks harvested during the 2023-2024 season. The L'Anguille River easily floods the landscape with minimal rainfall. Over the past six duck seasons, the farm has maintained flood conditions that kept every blind huntable throughout each season.

Additionally, located on the northwest corner, just south of County Road 210, it is an ideal site for constructing a hunting lodge. The property also offers excellent deer hunting for trophy bucks.

Landscape Description

- The tract encompasses approximately 430 acres situated within the Mississippi Alluvial Plain region. The majority of the land, roughly 290 acres representing 67% of the total area, consists of river bottom terrain linked to the L'Anguille River system. This bottomland features mature hardwood forests and wetland areas dominated by scrub-shrub vegetation including willow species, buttonbush, smartweed, and various water-loving plants.
- The meandering L'Anguille River winds its way across the entire property, creating approximately 2.5 miles of water frontage throughout the different parcels. Agricultural potential exists on about 140 acres, which accounts for 32% of the total acreage. These cultivated fields have a natural grade that descends toward the river corridor.
- An additional 4 acres of relatively flat, cleared ground runs adjacent to the southern boundary of County Road 210. This elevated area presents an ideal opportunity for constructing a hunting cabin or lodge, with the added advantage of direct waterway access to the L'Anguille River for boat launching.
 The land's primary value lies in its exceptional waterfowl hunting opportunities, particularly for ducks, while also providing whitetail deer hunting prospects in select woodland areas.
- The property is positioned in the Mississippi Alluvial Plain. 290.0 +/- acres (67%) of the acreage is bottomland associated with the L'Anguille River, comprised of hardwood timber and scrub-shrub wetlands (willow, buttonwillow, smartweed, and other aquatic vegetation). The L'Anguille River meanders through all land parcels providing 2.5 +/- miles of river frontage. 140.0 +/- acres (32%) is tillable farmland, which slopes toward the river. Located along the south of County Road 210 is 4.0 +/- acres, which offers an building site for a hunting lodge. This location is level and open, and has boat access to the L'Anguille River. The highest and best use of the property is for duck hunting with deer hunting available in areas.



Hunting Resources

- Overview This duck hunting property is strategically positioned along the L'Anguille River's major migration corridor, ensuring reliable duck travel throughout the season as birds move between feeding and roosting areas along the waterway. The river flows directly through the tracts, creating natural flooding patterns that significantly expand the effective hunting area beyond the property's boundaries.
- Habitat Features The land offers varied hunting environments that cater to different duck hunting
 preferences. Hunters can access timbered holes, willow-buttonwillow-smartweed dominated wetlands,
 and backwater holes that provide natural cover and resting opportunities. A 140-acre agricultural field
 serves dual purposes it can be managed for duck food plots while also functioning as a protected
 sanctuary area. This field, known as the "DU Field," includes water control systems and levee structures for
 water management.
- Hunting Infrastructure Seven permanent blinds are strategically placed throughout the property, with careful attention to spacing that allows three blinds to operate simultaneously without hunter interference. This thoughtful layout maximizes daily hunting opportunities for multiple parties.
- Hunting History Recent harvest records demonstrate exceptional productivity, with documented takes of 1,700 birds in the most recent season and 1,900 the previous year. The property's consistent performance stems from the L'Anguille River's natural overflow patterns ensure adequate water levels with even modest precipitation. Historical data spanning six seasons confirms that flooding has been sufficient to keep all blinds operational throughout every hunting season.




















































Devlin "Duck" Hodges
