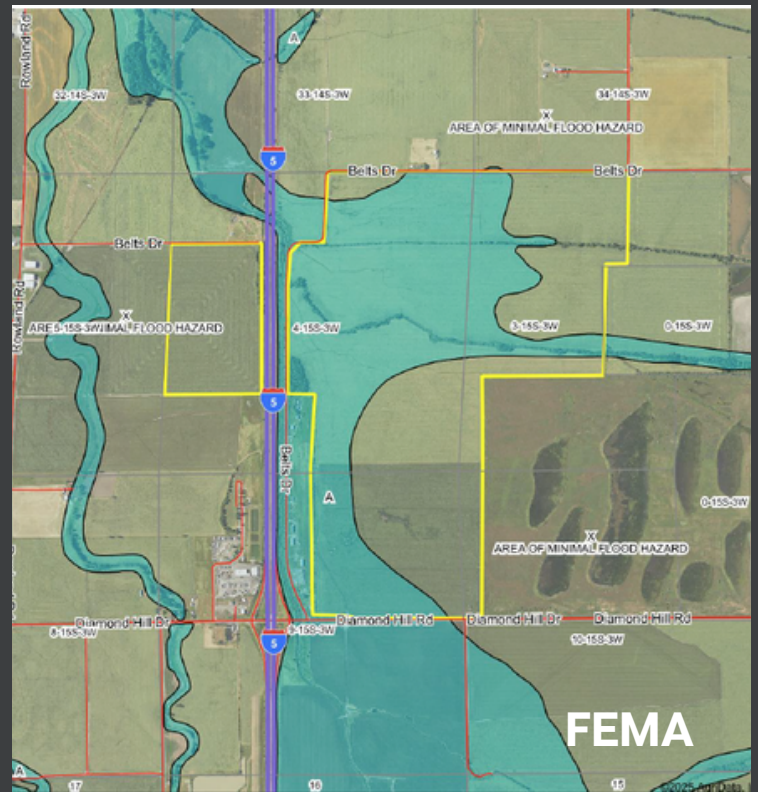
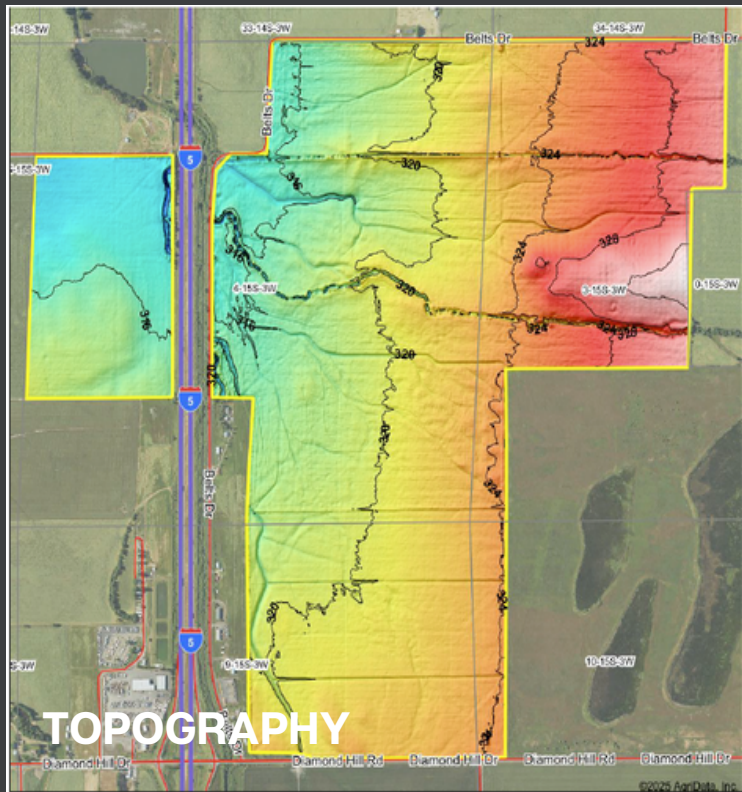
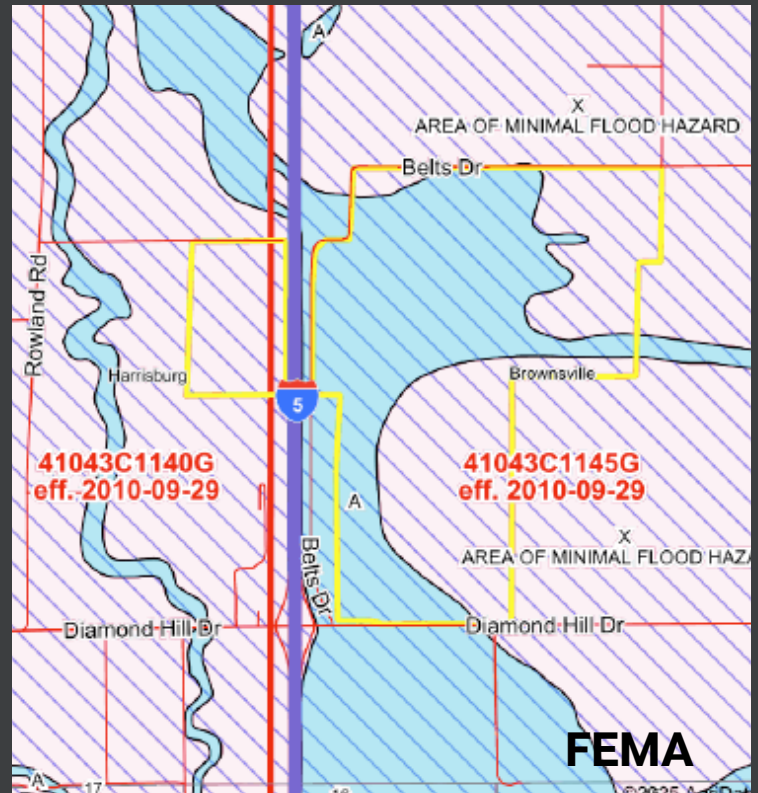
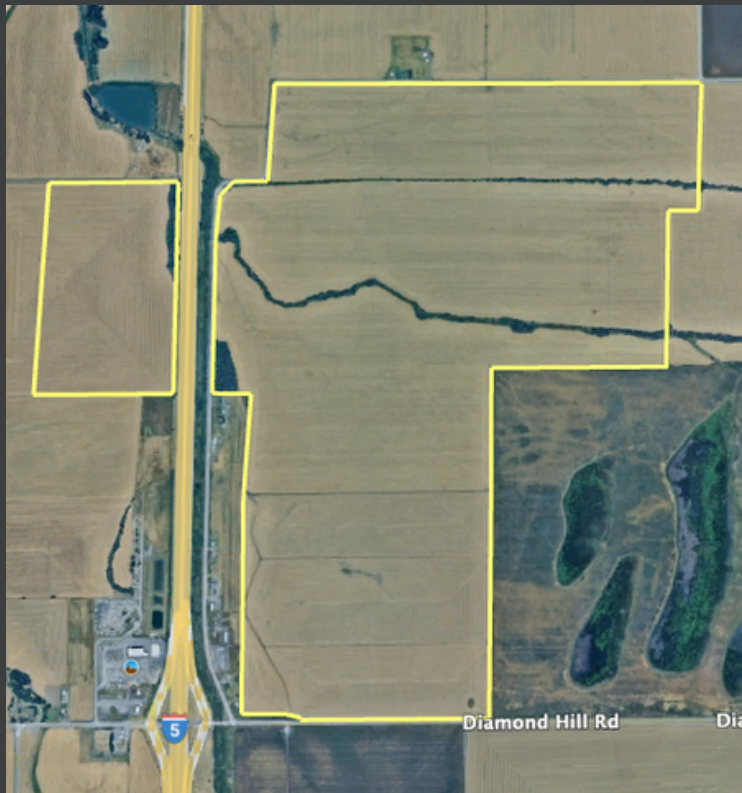
This expansive **±840.78-acre farm**, located in Linn County's Exclusive Farm Use (EFU) zone, offers a rare opportunity to acquire a large piece of quality Willamette Valley farmland along the Interstate 5 corridor, **less than 1-mile from I5 Exit 209**. The land features primarily Bashaw silty clay soil with influxes of Dayton silt loam, making it suitable for common dryland farm commodities for this area which is well known for its grass seed production. The terrain is mostly level to very gently rolling and is bisected by Pierce Creek and Tub Run, both seasonal waterways that flow into Little Muddy Creek. Minor portions of the property include light brush and trees, adding to its natural character without limiting agricultural potential. **Access** is convenient via paved county roads, including **Belts Drive and Diamond Hill Road**, with direct access to the farm fields. Elevations range from 309 to 334 feet above sea level. According to FEMA, the property lies within both Zone X (outside the 500-year floodplain) and Zone A (100-year floodplain). The property is currently leased through September 30, 2025. This parcel represents a **strong opportunity for agricultural use and/or long-term investment**.
