E. along a fence and with the West line of said Subject Tract a distance of 389.94 feet to a $1/2^{\circ}$ iron rod with plastic cap stamped "STOVALL & ASSOC." found (hereinafter called $1/2^{\circ}$ iron rod with cap found) for corner at the Northwest corner of said Subject Tract;


