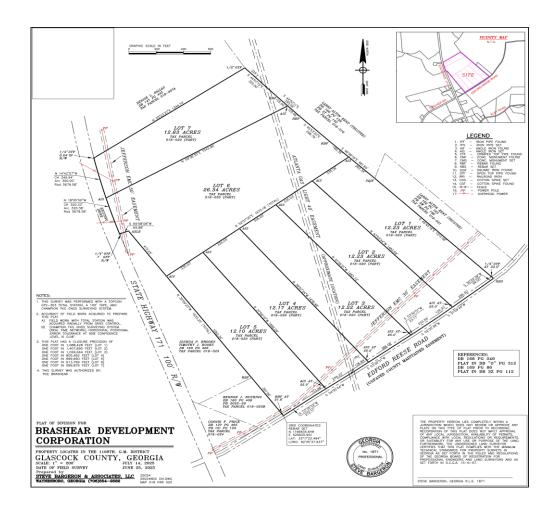








### **Plat of the property**

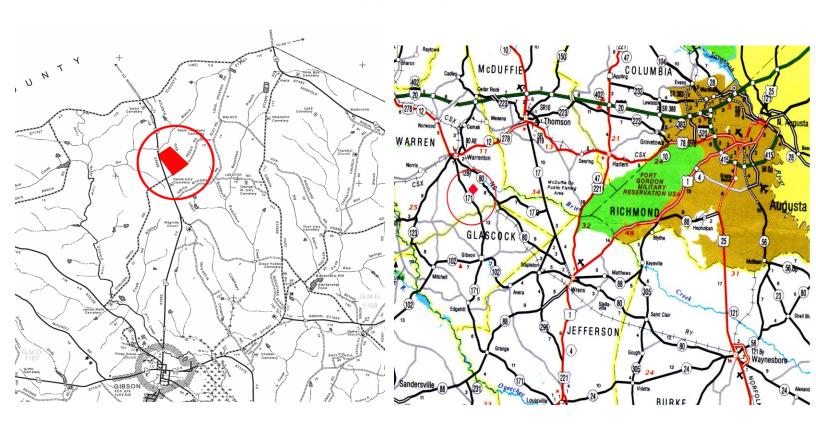
