The south end of the tract offers a different hunting experience, with established deer food plots, diverse timber stands, and abundant small game opportunities. At the heart of the property is a 40-acre stocked fishing lake, complete with multiple docks and a boat house, offering fishing for largemouth bass and catfish. A comfortable cabin with full utilities overlooks the lake, providing the perfect retreat for family weekends or hunting camp gatherings.
