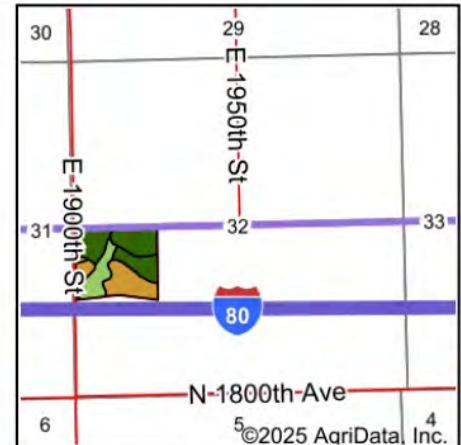

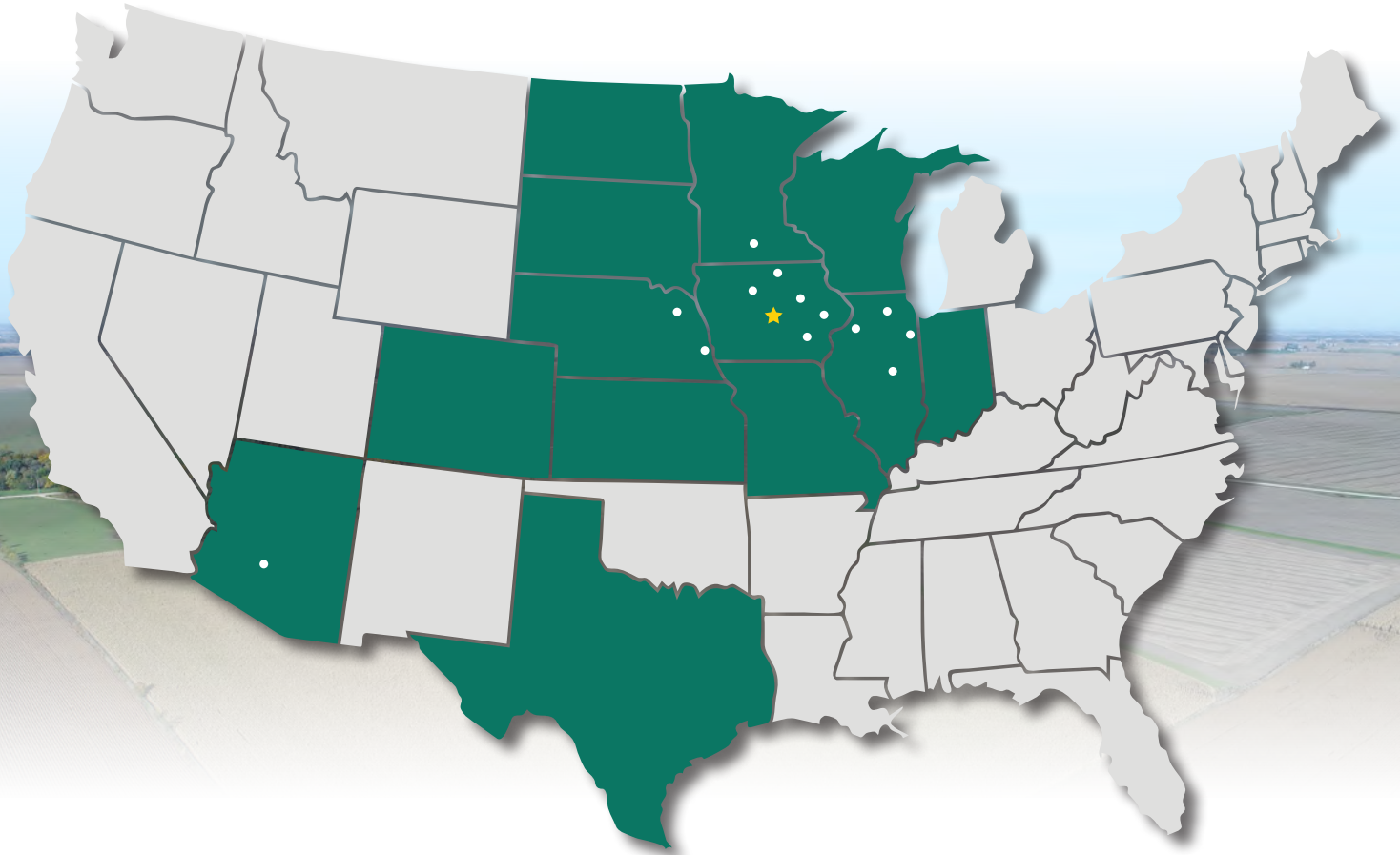
Terms of Possession
