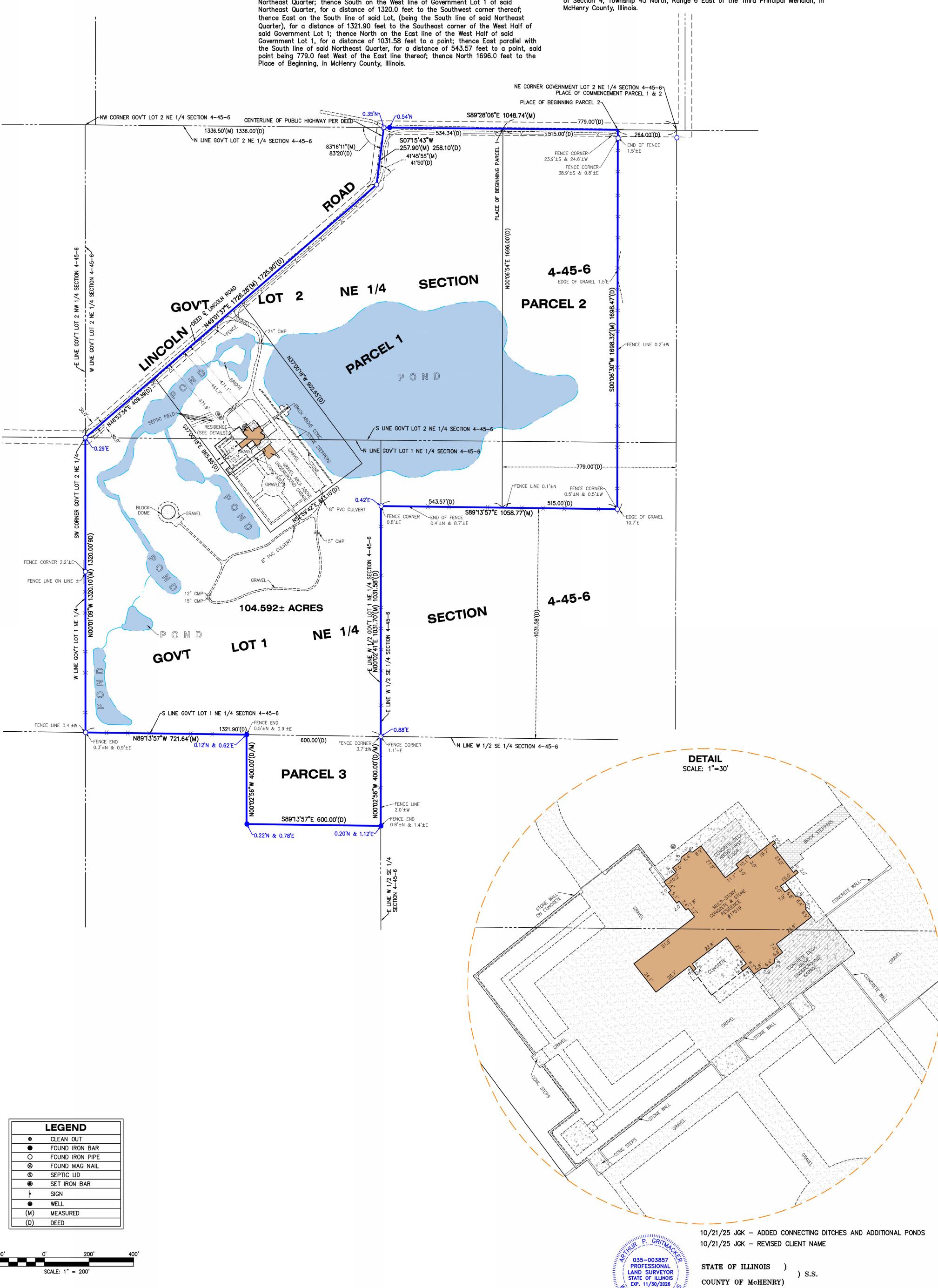

PLAT OF SURVEY

That part of the Northeast Quarter of Section 4, Township 45 North, Range 6 East of the Third Principal Meridian, (also known as Government Lots 1 and 2 of said Northeast Quarter), described as follows: Commencing at the Northeast corner of said Northeast Quarter and running thence West along the North line thereof, for a distance of 779.0 feet to a point for the Place of Beginning; thence continuing West on said North line, for a distance of 534.34 feet to a point, said point being 1336.0 feet East of the Northwest corner of said Northeast Quarter; thence Southwesterly on the centerline of a public highway, being on a line forming an angle of 83 degrees, 20 minutes, to the left, with a prolongation of the last described line, at the last described point, for a distance of 258.10 feet to an angle point in said centerline; thence Southwesterly along said centerline being on a line forming an angle of 41 degrees 50 minutes to the right, with a prolongation of the last described line, at the last described point, for a distance of 1725.90 feet to the Southwest corner of Government Lot 2 of said Northeast Quarter: thence South on the West line of Government Lot 1 of said Northeast Quarter, for a distance of 1320.0 feet to the Southwest corner thereof; thence East on the South line of said Lot, (being the South line of said Northeast Quarter), for a distance of 1321.90 feet to the Southeast corner of the West Half of Place of Beginning, in McHenry County, Illinois.

That part of the Northeast Quarter of Section 4, Township 45 North, Range 6 East of the Third Principal Meridian, described as follows: Commencing at the Northeast corner of said Northeast Quarter and running thence West along the North line thereof, for a distance of 264.0 feet to a point for the Place of Beginning; thence South parallel with the East line of said Northeast Quarter, for a distance of 1698.47 feet to a point on a line drawn 1031.58 feet North of and parallel with the South line of said Northeast Quarter; thence West on said parallel line, for a distance of 515.0 feet to a point; thence North 1696.0 feet to a point on the North line of said Northeast Quarter, said point being 515.0 feet West of the Place of Beginning; thence East 515.0 feet to the Place of Beginning, in McHenry County, Illinois.

The North 400.0 feet of the East 600.0 feet of the West Half of the Southeast Quarter of Section 4, Township 45 North, Range 6 East of the Third Principal Meridian, in
