A very well-kept older home on 40± acres of land with a barn that has horse stalls and a loafing shed. The home's ground level includes a large family room with a fireplace, a pantry coming off the kitchen, a master bedroom with full bath, a storm proof basement, utility room, and another bedroom and bathroom with extra storage. The upstairs has 2 bedrooms and a good-sized loft area. There are large closets throughout the home. There is an attached 2 car carport with a sitting area. The home has extra storage room just off the master bedroom.

The barn is 36' x 30' with an overhead door on the west, a walk-in door on the south, and on the east side two sliding doors for livestock to go into the steel corrals. The building has 3 stalls with outside access to the corrals. This building has served as a workshop and livestock barn with plenty of room for all uses.

The corrals have an alley that connects on the east and south sides with a large loafing shed and steel load out area. On the west side of the corrals is a fenced grass trap for livestock. There are several freeze hydrants on the property serving the corrals and a fenced in garden area south of the home. Adjoining a large circle driveway is a 20' storage container with walk-in door.

There are several trees in the beautiful homestead setting as well as fruit trees. The land is a mild rolling type terrain that could be planted to food plots or used for livestock grazing.

Updates to the home in the last 2-3 years are: central h/a on the ground level, 2 new hot water heaters, new submersible pump and pressure tank in the water well, and a roof by Moore's Roofing.
