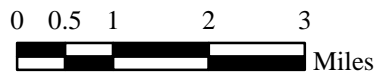
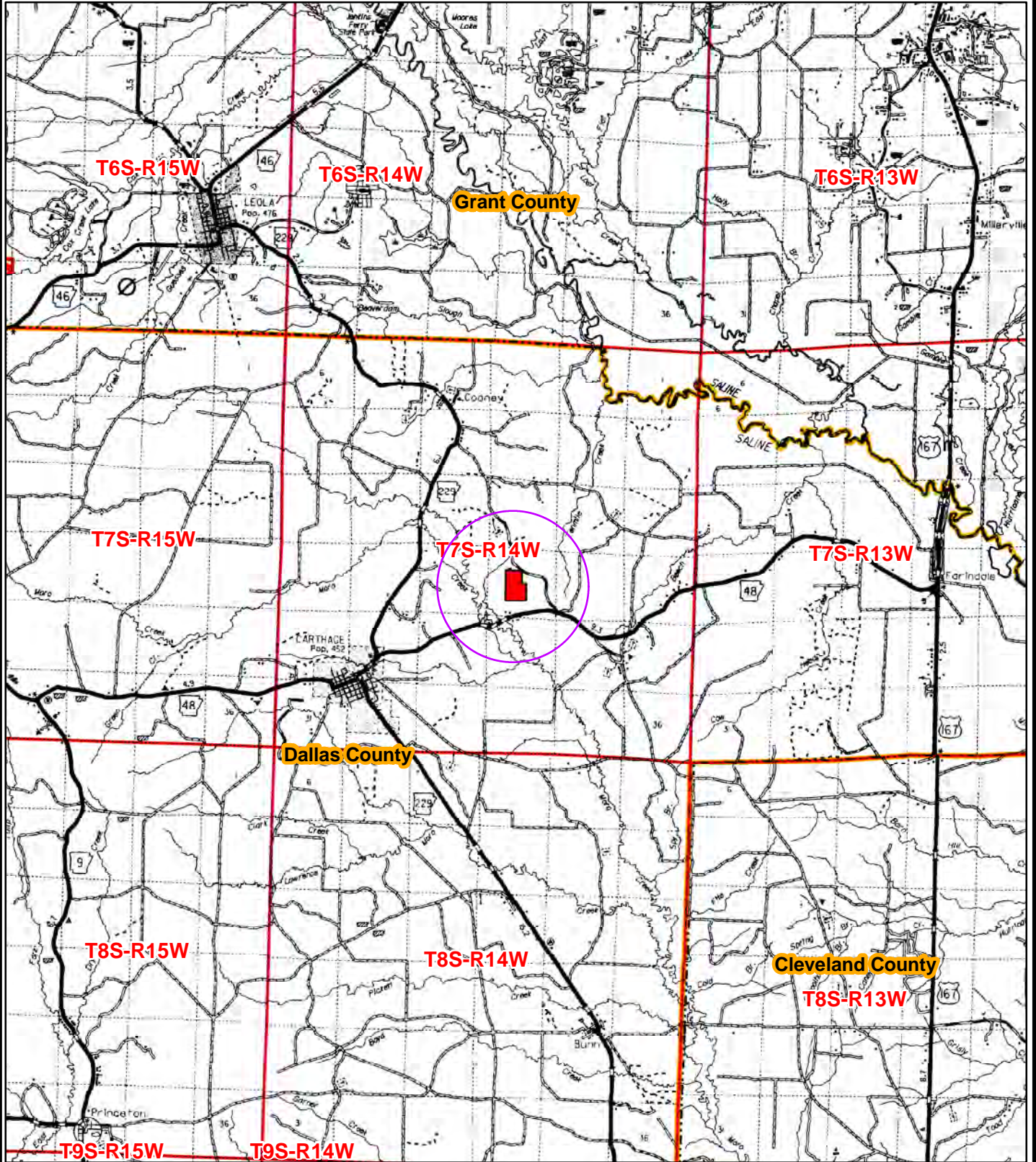
PROPERTY DESCRIPTION

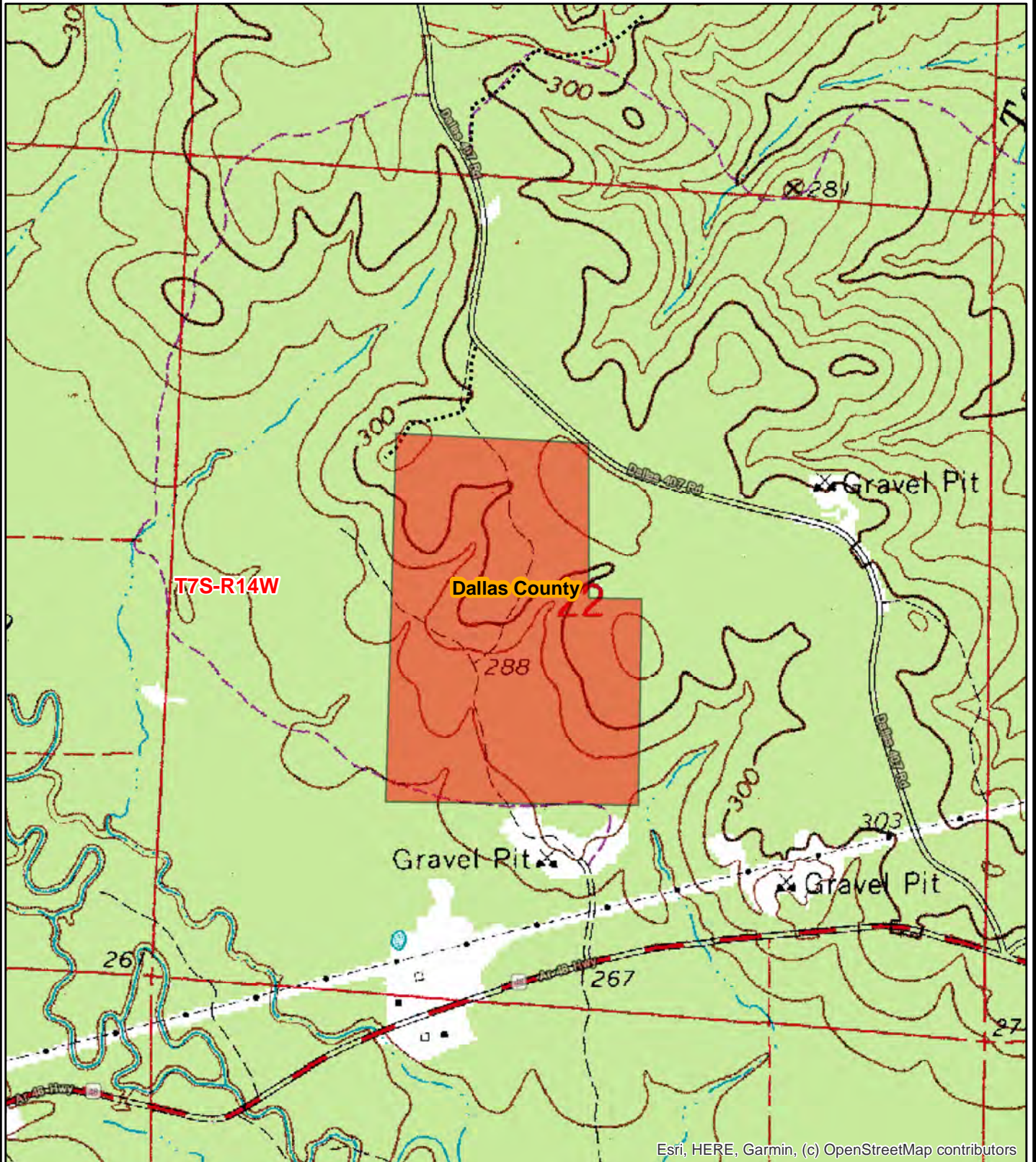

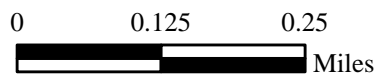
